
NEW YEAR, NEW GRADUATES: WINTER COMMENCEMENT



TWO STUDENT SCHOLARS SELECTED FOR PRESTIGIOUS SCHOLARSHIP

This year, two Union students were selected as recipients for the Jack Kent Cooke Foundation (JKCF) Undergraduate Transfer Scholarship. This is the first time that two JKCF finalists were chosen in the same year, making Junaid Ilyas and Carine Medellus the fifth and sixth scholars selected from Union overall. They will receive financial support of up to \$55,000 to complete their bachelor's degree, college planning support, ongoing advising, and the opportunity to connect with fellow JKCF scholars.

Junaid, of Roselle Park, graduated with an Associate degree in engineering and earned a 3.92 GPA. He was a Kaplan Scholar, a member of American Honors, and a peer tutor in the Academic Learning Center (ALC). Junaid also served as the senator for Union's Engineering Society and was part of Project Achievement, Union's student success initiative for Black male students. For Junaid's future plans, he will continue his education pursuing a degree in mechanical engineering, and plans to obtain his master's degree. He wants to become a vehicle engineer, more specifically being part of the innovation side of vehicle design, creating ideas that he believes "other gear-heads would go crazy over."



Carine, of Roselle, graduated with an Associate degree in biology a 4.0 GPA. She was the Committee Leader of Scholarship in PTK, Vice President of the Research Club, a member of American Honors, and an ALC tutor. She was also selected as one of only 20 students nationwide to be a member of the 2023 All-USA Academic Team. Carine will continue her education at University of Pennsylvania, studying biochemistry. She plans to focus her career on scientific research.

This year, Union had six semifinalists for the Jack Kent Cooke Foundation (JKCF) Undergraduate Transfer Scholarship - the most in Union's history! The semifinalists were Eman Abdelrahman, Ozichi Chinedu, Junaid Ilyas, Joceline Gissel Guerra Osorio, Yeicob Martinez, and Carine Medellus. The six semifinalists all had a GPA of 3.65 or greater, were members of Phi Theta Kappa (PTK), the International Honor Society for two-year colleges, and were involved in various clubs and activities during their time at Union.





SOCIAL WORK SERVICES DAZZLES WITH HISTORIC PARTNERSHIP

As the Fall semester commenced, the College began receiving more than 1,000 pounds of food monthly from the Community Food Bank of New Jersey, located in Hillside. This donation was secured through a new partnership with the food bank, and Social Work Services was able to order food and supplies to stock the College's food pantry for free. Thanks to this incredible donation, the College was able to help nearly 250 students by distributing more than 15,000 pounds of supplies.

Thanks to the support of the honorees and the committee, this year's event raised more than \$60,000 to help support the College's strategic initiative to increase the African American graduation rates. Highlighted by messages from NBC Nightly News's Lester Holt, rap royalty Darryl McDaniels of Run-DMC, and a keynote address from student speaker Peterson Jean, the guests were both entertained and informed on the mission of this vital campaign.

Since the start of the campaign, more than \$400,000 has been raised and invested in scholarships, grants, program support, and has provided emergency funding for students on track to graduate. The College's graduation rate for African American students has grown exponentially over the past seven years thanks to this vital initiative.





FOUNDATION HOSTS SCHOLARSHIP RECEPTION

Due to the pandemic, the Union County College Foundation has not hosted an in-person scholarship reception since 2019, but in March, hundreds of donors and their scholars finally came together. It was a tremendous night for students to meet the donors who are having such a positive impact on their lives. The Foundation also welcomed fifteen new members to the scholarship family.

Doug Rouse, Foundation Executive Director, was proud to share with the attendees that for the eighth consecutive year, thanks to the generosity of Foundation donors, over \$1 million in direct scholarship and grant support was provided to Union students. Nearly 30% of this year's graduates received direct support from the Foundation.

ALATARY MEMORIAL SCHOLARSHIP

Awarded to a full- or part-time student with a minimum 2.5 GPA enrolled in an Automotive Technology (A.A.S.) or certificate program. Preference will be given to a student in financial need. Recipient must remain enrolled in their originally identified program, remain in good academic standing, and continue to demonstrate financial need to be eligible for renewal of scholarship for one additional year.

BRAIL MANGER NURSING SCHOLARSHIP

Awarded to full- or part-time Nursing students with a minimum 2.5 GPA. Recipient must have completed a minimum of 15 credits. Preference will be given to those students who demonstrate financial need.

BRISTOL MYERS SQUIBB STEM SCHOLARSHIP

Awarded to full-time students with a minimum 2.5 GPA. Recipient must either be of Hispanic or African American descent.

THE EQUANIMITY **SCHOLARSHIP**

Awarded to a full- or part-time student with a minimum 3.0 GPA at the time of application and have completed a minimum of 12 credits. Applicant must complete an essay on how the scholarship will benefit them. Preference will be given to student who demonstrates a financial need.

GREATER ELIZABETH CHAMBER OF COMMERCE **SCHOLARSHIP**

Awarded to a full- or part-time student. The scholarship will be awarded on the basis of financial need.

JOE HINES CRIMINAL JUSTICE SCHOLARSHIP

Awarded to a full- or part-time student with a minimum 2.0 GPA majoring in Criminal Justice. Awarded to a student who demonstrates financial need.

THE JARAMILLO-**REGALADO GRIT SCHOLARSHIP**

Awarded to a full- or part-time student with a minimum 3.25 GPA, that exemplifies the values of grit and determination, and has completed a minimum of 6 credits. Recipient must be either a naturalized U.S. citizen, permanent legal resident, DACA or undocumented immigrant, U.S. citizen child of immigrants, a non-traditional student (25+), or an international student. Student will be required to submit an essay that shares their personal journey, goals, how they overcame adversity and implemented grit to overcome obstacles in their path. Preference will be given to a student who demonstrates financial need.

MARIANNE M. KERWIN **SCHOLARSHIP**

Awarded to a full-time student with a minimum 3.5 GPA at the time of application. Recipients must be a Mathematics major or an Education major concentrating in Mathematics.

LES MALAMUT ART GALLERY ARTIST SCHOLARSHIP

Awarded to a full- or part-time Art student majoring in either Visual Arts or Graphic Design. Recipient must have a minimum 3.0 GPA and have completed a minimum of 12 credits. Preference will be given to students who demonstrate financial need.

FLORENCE FUCHS LEVY '01 **SCHOLARSHIP**

Awarded to a full- or part-time student with a minimum 2.8 GPA. Recipient must be a non-traditional student, age 30+. Preference will be given to those students who demonstrate financial need.

MAGUIRE FAMILY NURSING SCHOLARSHIP

Awarded to a full-time student enrolled in the Trinitas School of Nursing program, who has a 3.0 GPA at the time of application. Preference will be given to a student who demonstrates financial need.

BERNADETTE MURPHY SCHOLARSHIP

Awarded to an incoming or current full- or part-time student who has a minimum 2.5 GPA at the time of application. Recipient must be a single parent and a first-generation college student.

NATIONAL BOARD OF RESPIRATORY CARE **SCHOLARSHIP**

Awarded to full- or part-time students with a minimum 2.5 GPA at the time of application. Recipient must be enrolled in Respiratory Care or Respiratory Therapy field of study.

THE NEXT CHAPTER **SCHOLARSHIP**

Awarded to a full- or part-time female student. Scholarship will be awarded to a non-traditional student, age 25+. Preference will be given to students who demonstrate financial need.

WOMEN EMPOWERMENT **CLUB SCHOLARSHIP**

Awarded to full- or part-time female students. Preference will be given to a student who demonstrates financial need.

WOMEN 100 PROJECT COMES TO UNION

The Union County College Foundation's Women 100 Project was developed by volunteer leaders to provide direct scholarship and emergency grant support to female students at Union, invest in programming to help women succeed on campus, and ultimately provide overall services that are specific to female students' needs. This fund ensures that Union's financial aid and social work teams have the flexibility to meet the needs of female students. The goal of this campaign is to see a dramatic increase in the support offered to full- and part-time female students, develop a network of empowered women, and inspire the next generation of female leaders.

Since its inception, the Women 100 Project has provided scholarships for single mothers in need and has hosted empowering events, including a breathing and meditation class to assist with mental health and stress. This year, the fund was used to purchase feminine essentials and toiletries for female students on campus and helped provide emergency assistance for female students in need. For example, a single mother needed help paying for day care. The Women 100 Project met her need immediately to ensure she was able to continue on her educational path. The program also inspired students on campus to develop their very own Women's Empowerment Club.

In its first year, the Women's Empowerment club coordinated weekly meetings to empower female students on campus, held fundraisers that assisted with purchasing additional feminine essentials as well as establishing a \$1,000 scholarship for female students at the College. The Women Empowerment Club is one of the first student-led clubs to create its own scholarship! Thanks to the Women 100 Project, positive change is happening on campus for all female students.

GLASSER CENTER FOR STUDENT ATHLETE ACADEMIC ACHIEVEMENT UNVEILED

This May, College and Foundation leadership came together with student athletes to officially dedicate the Glasser Center for Student Athlete Academic Achievement. The Center is named in the memory of former College Board of Governors member, Dr. Gerry Glasser, and his son Thomas. The Center's purpose is to ensure that student athletes have the resources they need to compete on the field as well as excel in the classroom. This was made possible by a generous \$250,000 commitment from the Glasser Foundation to the Union County College Foundation.





OPERATION GRADUATION FUND PROVIDES LAST DOLLAR SUPPORT

Nothing is more important at Union than graduation. All our efforts are centered around making sure that students graduate on time. In 2015, the Foundation launched the Operation Graduation campaign that supports the College's strategic initiative to increase graduation rates. This past year, the Foundation was called upon to provide financial support to a number of the most vulnerable students in need of summer classes to graduate. Thanks to the support of the donor family, initiated through a very generous donation from the Summit Foundation, the Foundation was able to meet the needs of each of these students and more importantly, help them complete their degrees on time.



FACULTY AND STAFF CHANGING LIVES OUTSIDE THE CLASSROOM

Student success is the hallmark of the College's institutional core values. Nothing is more important than ensuring all students have an opportunity to succeed. ALC ILLUMINATES STUDENT SUCCESS

Since its inception in 1985, the Academic Learning Center has been a beacon for student success. The ALC provides students with free peer tutoring on the Cranford, Elizabeth, and Plainfield Campuses. On average, there are more than 50 ALC tutors across the Campuses. These tutors have reached high levels of academic success in their given tutoring field and provide support for fellow students. Students that enter the ALC for tutoring receive help and

assistance to have a better understanding of their course, receive the support to reach their academic goals, and foster a positive role model experience between the peer tutor and the student they are helping.





Smithsonian

COLLEGE SELECTED TO HOST ESTEEMED SMITHSONIAN GALLERY

This year, Union was one of only six schools across the state selected to host the Smithsonian exhibition Museums on Main Street: Voices and Votes, Democracy in America. The exhibit examined the nearly 250-year-old American experiment of a government "of, by, and for the people" and how each generation since continues to question how to form a "more perfect union." The project director was Union's Academic Specialist in History Joseph Margiotta, who contributed pieces from his personal collection to enhance the exhibit. Several historical moments were celebrated while the exhibit was at Union, including Hispanic Heritage Month, Indigenous Peoples Day, Election Day, and more. Union students, faculty, staff, as well as members of the community were welcome to tour the exhibit, with nearly 750 history seekers taking the opportunity to visit.



AMERICAN HONORS PROGRAM HAS A ZEST FOR SUCCESS

The American Honors Program at Union is for high achieving, academically motivated students with a 3.25 cumulative GPA, who attend courses full-time at Union, and plan on transferring to a 4-year institution after graduating. Students accepted into the American Honors Program have access to small class sizes of less than 20 students, professional academic advising, transfer support, and access to the Honors Lounge.

This November, the American Honors program hosted a symposium which featured projects of honors students. Nearly 50 students participated at the symposium, presenting their project, the outcomes, and what they learned from their research to fellow students, faculty, and staff.



STUDENT SELECTED AS KAPLAN LEADERSHIP **SCHOLAR**

Union student and Jack Kent Cooke Foundation Undergraduate Transfer Scholarship recipient Junaid Ilyas was one of only 11 students selected across the country as a Kaplan Leadership Scholar. The Kaplan Leadership Scholar Program supports students at two-year schools who plan on continuing their education at a

four-year institution, demonstrate financial need, leadership potential, and reach high academic achievements. The program removes financial burden from scholars by providing scholarships, transfer admissions support, and assists them with personal development and leadership growth.

STEM DEPARTMENT SPEARHEADS RESEARCH DAY

Union's annual Research Day featured more than 90 STEM students presenting their research projects to the Union community, an external evaluator, and Union alumni. Students displayed their projects on posters and discussed their findings with guests. Two Union alumni, Ana Raquel Castro E. Costa and Alessandra Costa served as mentors for the day and discussed how their time at Union benefited them. Both graduates are completing their bachelor's degree and will attend Johns Hopkins University for their graduate degrees.



FROM PITCHES TO PROFIT

Students across the country continue to expand their entrepreneurial endeavors as they pursue their degree. Because of this, the College hosted a Business Pitch Competition, for students to present their business proposals for a panel of five judges who work in the business industry and receive feedback. After 20 students attended workshops across an eight-week period, a panel of faculty and academic specialists at Union reviewed the proposals. Ultimately, 11 were selected for the final pitch, with Nicholas Mont coming out on top, winning a \$6,000 prize for his business concept. The winning pitch addressed the issue of food waste, and his slogan for his concept was "Dehydrated food is healthy, delicious, and a sustainable solution to end world hunger." This event was led by Dean of Social Sciences, Business, and History Dr. Melinda Norelli and Director of the Business Center Dr. Donovan Smalls and was funded by the Opportunity Meets Innovation Challenge Grant funded by the state of New Jersey.



ARCHIVE EXPLORERS PRESENT IN PHILLY

Four Union students were invited to present their poster, Student Voices at Union College, at the undergraduate poster session at the American Historical Association conference, Pam Pereyra, Rachel De La Cruz, Diana Benenaula, and Cayla Kerekgyarto conducted research in the College's archives. The students' work focused on student newspapers in the 1960s-70s and examined the impact of growing diversity on social movements and college policies. Based on their research, the students submitted a proposal to the American Historical Association, which was accepted. Pam, Rachel, Diana, and Cayla, accompanied by Associate Professor of History Dr. Michele Rotunda, attended and presented at the conference in Philadelphia.




PRINCETON SENDS OWLS TO TIGER TERRITORY

Princeton University offered four Union students the opportunity to participate in a summer intensive program. Dejanayha Hill, Katherine Mejia, Gabrielle Mojena, and Precious Opaola were four of only 35 students selected across New Jersey for the summer program. The students took two four credit courses

at no cost. During their program, they received peer tutoring, access to several facilities at Princeton, and transfer support services.

ARCHIVES RAISE A RACKET

As part of a Women in American History course, 20 students participated in a history lab. It focused on the College's Archives, specifically, the case in which the National Junior College Athletic Association (NJCAA) suspended Union from the championship competition. Their basis for suspension? Union allowed a woman named Ellen Magliaro to play on the men's tennis team in 1972-73. The student researchers investigated news accounts, made inquiries with a variety of organizations (NJCAA, National Archives, the federal court system), and conducted several interviews with key figures including Ellen Magliaro, former athletic director and current Dean of STEM William Dunscombe, and named plaintiff in the civil action Michael Johnson.

YOUNG OWLS EXPLORE THE NEST

Union continues to offer dual enrollment for high school students to earn college credits, but beginning in 2022, it was at no cost to them! The 2022 Summer College Program sponsored 37 Union County high school rising Juniors and Seniors to earn up to 6 free college credits in English and STEM. Students were able to choose from select courses, receive academic support, participate in career counseling, and build relationships with other Union County high school students. This program was grant funded, making it free for students, their families, or school districts. In addition to coursework, high school students engaged with the Union community and explored careers in STEM. Guest speakers presented to the students, including a mobile forensic demonstration by the Union County Prosecutor's Office, the Westfield YMCA, the IRIS House, and Colleen Rodgers, Sr. Managing Director of STEM, Teach for America.

EOF HOSTS FIRST ANNUAL SUMMER OLYMPICS

Every summer, Union's Educational Opportunity Fund (EOF) offers three opportunities to enhance the education of incoming freshmen. The Math and English Institutes equip first-time college students with the skills they need to succeed in college-level courses. In addition, EOF provides workshops and excursions to provide scholars with a well-rounded experience. To mark the end of the institutes and the start of the new academic year, EOF hosts an annual BBQ. This year, EOF introduced their first-ever EOF Olympics, inviting participants from all three summer institutes and current EOF students to attend. The event was a fun-filled day with around 40 students enjoying food and games to celebrate the start of a new journey.



ARCHITECTURE STUDENTS PITCH **BUILDING DESIGNS**

Twenty Architecture students participated in a project to design a mixed-use building that housed a senior day care, a hospice center, and apartment units, that was adjacent to an existing Mosque and would serve their congregation. The judges for the project included architectural graduates from NJIT and a developer who was building a similar project to which the students were assigned.



TRINITAS SCHOOL OF **NURSING CELEBRATES 170TH** GRADUATING CLASS

Trinitas School of Nursing, in partnership with the College, provides a Cooperative Nursing Program that awards students with both a diploma in Nursing from Trinitas School of Nursing and an Associate in Science from Union. Two ceremonies were held in January and June, celebrating a combined 139 graduates. This year's June ceremony marked the 170th graduating class for the nursing program. The graduation ceremony features a traditional pinning ceremony, which symbolizes a rite of passage into the professional world of nursing and the nurse's commitment to those they care for. The ceremony concluded with the graduates taking their oath as graduate nurses.

A BREATH OF FRESH AIR: 15 STUDENTS GRADUATE FROM UNION'S RESPIRATORY CARE **PROGRAM**

After completing the Respiratory Care Program, fifteen students celebrated their Annual Pinning Celebration this past May. Attendees included Union's Vice President of Academic Affairs Dr. Maris Lown, Dean of the Plainfield Campus Dr. Victoria Ukachukwu, clinical directors and instructional staff, laboratory staff, as well as the family and friends of the graduates. Students in the Respiratory Care Program graduate with an Associate in Applied Science degree and are eligible to sit for the National Board of Respiratory Care credentialing exams. Graduates in this program are prepared to administer medical gases and aerosolized drugs, assist physicians with diagnoses, and provide treatment and care to patients with disorders of the heart and lungs.



PRACTICAL NURSES SHINE AT PINNING CEREMONY

Union's 27 practical nursing graduates celebrated their pinning ceremony at the Cranford Campus this past May. Dr. Christiana Nwachukwu and Michele Cislo, Associate Professors in Practical Nursing, awarded the pins to the graduates. Following the pinning, the graduates took the Nurses' Pledge and lit candles, led by Donna Sonsiadek, Associate Professor in Practical Nursing. The candles commemorate Florence Nightingale's nighttime aid to wounded soldiers by candlelight.





SUMMER EMT PROGRAM

Every summer, students complete Union's emergency medical technician (EMT) program. This year, nearly 50 students finished and have already successfully completed the National Registry Certification examinations. The program is an intense 6-week program, which includes lectures, labs, and field experiences in the local hospital emergency departments, as well as local EMS agencies.

Students are fully immersed in the EMT experience with patient assessment relay races, major bleeding control ensuring proper use of tourniquets and hemostatic dressings, childbirth, splinting, and hands on experience using simulated and actual EMS ambulances. Near the end of the program, students enjoy a cultural inclusiveness luncheon where they brought in favorite family recipes and share insights on how EMTs should respond to a member of their family in need.

UNION EMBRACES HERITAGE MONTHS

In September, the College kicked off the academic year with Hispanic Heritage Month. Various celebratory months were held at the College throughout the year, including Black History Month, Women's History Month, and more.

On September 15, Union marked the beginning of Hispanic Heritage Month with an opening ceremony. Students processed through the Victor M. Richel Student Commons with flags from Hispanic countries and keynote speaker Yolany Gonell, the Director for Student Diversity and Inclusion at William Patterson University, discussed inclusivity and representation among Hispanic students. Celebrations throughout the month included sampling authentic Hispanic foods, events with Hispanic music, and showing movies that honor Latin culture.

In October, the College celebrated LGBTQ+ History Month, with a Progress Pride Flag hung on each of the campuses. The College celebrated National Coming Out Day and National Pronoun Day by wearing pins with people's preferred pronouns and distributing flags. Finally, the celebration concluded with Spirit Day as supporters wore colors in honor of the LGBT+ Flag.

Native American Heritage Month was recognized in November. Native American dancers and singers in traditional garb performed for the College community and told their stories. Several speakers came throughout the month, including a speaker from the Museum of Early Trade and Craft, that spoke on traditional Lenape traditions.

The College celebrated Black History Month in February. The theme was "Celebrating Black Excellence," and the kickoff event included Union's Coordinator of High School Initiatives Tawn Walker singing the Black National Anthem, followed by Union student Chelsea Jean-Marie performing a dance. The keynote speaker was Kristine Smith, the CEO of InSpira Performing Arts & Cultural Center, who spoke on Black history and excellence. The month also featured sampling of traditional African American foods, dances, and featured performer Christopher Slaughter, who came and spoke about African American culture through the lens of poetry and hip-hop.

The Overwatch 2 team members include: Oscar Alvarez, of Elizabeth (Team Lead); Alexander Garcia, of Rahway (Team Captain); Jake Castro, of Elizabeth; Kevin Loureiro, of Linden; Lucas Chudoba, of Elizabeth; and Jose Paredes, of Roselle. Additionally, Jake Castro was runner up for NBA2k against Heartland Community College 1-3. The team is led by head coach Duane Reid, Union's Director of Student Success Initiatives, and assistant coach Samuel Sanchez.









FINALS AT THE FAIRWAY

Freshman golfer Patrick Murray competed in the NJCAA National Golf Championship in Chautauqua, New York, following a third straight win. At Nationals, Patrick fired a final round of 78, which along with his rounds of 79, 76, and 76, earned him 18th place and All-American Honors. Because of his Freshman status, he receives an automatic return bid for next year.

WOMEN'S BASKETBALL (AND THEIR COACH!) SLAY THE GSAC

For the sixth year in a row, the Women's Basketball team was named the 2023 Garden State Athletic Conference (GSAC) Champions, after a sweeping victory over Essex County College, with a final score of 70-41. The team was not the only champion of the GSAC, their coach was too! Women's Basketball Coach and Director of Athletics Marbely Montas was named GSAC Coach of the Year. Coach Montas is a Union '07 alumna and has served as coach since 2017.

A RUN FOR SUCCESS

In May, the Track & Field team headed to Utica, New York to compete in the NJCAA Track & Field National Championships. Thomas Flanagan won 2nd place in the country for Men's Javelin. This is Thomas' second year competing with Union; in 2022 Thomas was the National Champion in javelin with a throw of 56.27 meters. Runners Kamia Boykin, Love Baker, and Dillon Dering all broke their personal records in the

100m, 200m, and 400m races.



WRESTLING TEAM QUALIFIES FOR **NATIONALS**

Three Union wrestlers brought the heat to the mat as they qualified for the 2023 NJCAA National Tournament. Oscar Serrano, Alex Dorce, and Angel Castillo represented Union and traveled to lowa for the competition. To qualify for nationals, Oscar and Alex won the Gulf Atlantic District/Region 19 Championship for their weight class with Angel Castillo placed third. Angel was the first wrestler from Union's program to qualify for the National Tournament in his weight class. Oscar Serrano is finishing his career as a two-time NJCAA National Qualifier and is the team's first Scholar All-American and first Gulf Atlantic District Champion.

MEN'S VOLLEYBALL BLAZES COURT IN **INAUGURAL SEASON**

Thanks to a \$10,000 grant from the NJCAA and First Point Volleyball Foundation, Men's Volleyball came to Union for the first time in 2023. Following the gameplay and sportsmanship gained throughout the season, the team was invited to compete in the 2023 NJCAA Men's Volleyball Invitational, held at the College of Dupage, in Chicago. Led by Coach Kevan Pidgeon-Hammock, who also serves as a Student Services Generalist in College Life, the team competed against undefeated Monroe College and Region XIX Champion Ocean County College, where they put up a tremendous fight. Despite the loss, the teamwork and player performances were the strongest of the team's season.

BELOW ARE A FEW HIGHLIGHTS FROM THE YEAR


College Life kicked off the start of both semesters with Welcome Week, which included giveaways, opportunities to get to know each of the campuses, involvement fairs, and more.

The **Cybersecurity Club** took a group of 50 students to the Spyscape Museum in New York City, which included a trip to the Rockefeller Christmas Tree. Students dodged lasers, broke codes, ran surveillance. As this was occurring, an algorithm, developed by a former Head of Training at MI6, created a personalized profile of the students skills and attributes. The club advisor was Academic Specialist in Computer Science Al Elbanna.

The **History Club** led an educational trip to Philadelphia. More than 30 students attended, visiting many noteworthy historical sites including the Liberty Bell, the Benjamin Franklin Museum, and Independence Hall.

The **Business Club** hosted an Entrepreneur Marketplace for student entrepreneurs to present their innovative ideas to the student body and gain feedback for them to grow their companies. They used their marketing and sales skills to introduce themselves and their new businesses. This event offered students that ability to reach a different audience and gave them the confidence necessary to move ahead with their entrepreneurial spirit. Businesses featured in the Marketplace included a trucking company, a business for wedding accessories, artists, and more.

The **Criminal Justice Club** visited the Union County Police Academy. The trip included a tour of the police academy, a defensive tactics demonstration, and an opportunity to train on a Firearms Training Simulator. Part of the day also included a police K-9 demonstration with the animals and their handlers. Students were engaged in thinking about real-life scenarios and incidents, with the challenge to use critical thinking skills and discuss different decisions based on police tactics, procedures, and understanding applicable laws. The day concluded with students participating in a question-and-answer session with instructors of the academy.



MORE TREES, PLEASE!

Union's Earth Day celebrations commenced on April 22, 2023, 53 years following Union's first and now annual celebration. This year's theme was "Invest in our planet. Take Action. Be part of the Green Revolution." With that theme in mind, students from Academic Specialist Shahrzad Taghdissi's chemistry class threw "green grenades" onto the three islands located on the Cranford Campus' pond. Green grenades are composed of red clay, compost, and wildflower seeds. When the grenade lands, the seeds germinated and are in the process of establishing a perennial wildflower "garden" on each island, containing Black Oil Sunflowers, Coneflowers, Black Eyed Susans, White Yarrows, Common Milkweeds, and Lycorises. After the seed bombing, students, staff, and faculty were invited to paint an Earth Day Canvas painting in the Science Building on the Cranford Campus.

To conclude Earth Day celebrations, Dr. Thomas Ombrello, Senior Professor in Biology, held the ceremonial planting of a tree in the College's Historic Tree Grove. The Historic Tree grove was established in 1995 and currently contains 75 trees of historical significance.

The tree planted this year (number 76) is the offspring of the Valley Forge Sycamore. The parent tree was a witness tree and grew next to a farmhouse at Valley Forge. Valley Forge was part of the encampment site for George Washington's Continental Army during the winter of 1777-1778.


PRESIDENT MCMENAMIN AFFILIATES WITH EXCELENCIA IN EDUCATION



FALL 2022 PELL ELIGIBILITY












FALL 2022 FTFT COHORT, TOP ENROLLED MAJORS

The cost of obtaining a college degree should not be a financial burden for the student. For this reason, along with the County and State support, there will be no increase to tuition rates and course fees for FY2024. This marks the fourth consecutive year of no increase in tuition.


The focus on student success remains a top priority. The College engaged Ellucian Grant Services to assist with the sourcing and development of grant opportunities to benefit academic programs and student services. The pandemic demonstrated the importance of mental health and student basic needs. As such, the College is investing in its social services to connect students to resources so they can be successful while earning their credentials.

Over the last three years with the assistance of pandemic-related funding, the College improved its remote learning and student experience environments, upgraded technology and furniture, and provided students with basic needs assistance. Management understands the importance of maintaining these efforts. Subsequently, the fiscal year 2024 budget expands upon these initiatives responsibly. The College is excited for the future as we continue the mission of transforming our community, one student at a time.



THANK YOU FOR YOUR SUPPORT

This spring, the College and the Union County Board of County Commissioners held their Board of School Estimate hearing, at which funding by the County for the College's operating and capital expenses was allocated for the upcoming 2023-2024 year. In attendance for the hearing were the delegates to the Board of School Estimate: Union College Board of Trustees Chair Victor M. Richel, Trustee George A. Castro II, and Trustee Miguel A. Merino; Union County Commissioner Chairman Sergio Granados, Commissioner Vice Chairwoman Kimberly Palmieri-Mouded, and Commissioner Lourdes M. Leon. Also present were 30 Union students, from both credit and non-credit divisions, who thanked the Commissioners for their generous support which has allowed the College to keep tuition low with no increase for four consecutive years. The hearing confirmed funding for the College of more than \$16 million in operating and more than \$4.5 million in capital from the County for the renovation of the gymnasium on the Cranford Campus.



On the opposite page is a graphic depicting the current economic impact the College has on Union County. Lightcast, an economic research firm based in Idaho, released a study on the economic impact of the College on Union County. The results revealed a positive impact of Union on the regional economy in large part through the College's ability to enhance graduates' careers with increased job opportunities and higher incomes. Among the most noteworthy impacts of the College on the community:



- The College produced increased earnings from alumni of \$346.9 million
- Residents of Union County who complete an associate degree earn an average of \$48,900 per year – which is \$10,900 more than a high school graduate in Union County earns.
- One out of every 71 jobs in Union County is supported by the College and its students



UNION THROUGH THE DECADES

The College has been providing excellent and affordable educational opportunities for Union County residents for almost 90 years, transforming our community, one student at a time.



UNION'S HISTORY

- 1933: Union County Junior College opens on October 16 as an "emergency junior college" with evening only classes at Abraham Clark High School in Roselle.
- **1934:** Dr. Hubert Banks Huntley becomes the first chief administrator of Union County Junior College.
- 1935: Dr. Charles G. Cole succeeds Dean Huntley and is considered the first "President."
- 1936: Union County Junior College is established as a non-profit institution governed by a Board of Trustees.
- **1936:** The College changes its name to Union Junior College (UJC).
- 1940: Basketball is the only varsity sport at Union. The '39/'40 girl's basketball squad captures first place in the "Powderpuff League." This is the first championship for a UJC Team.

- 1941: The College begins offering day courses on Sept. 1 and continues to use the laboratories at Abraham Clark High School.
- 1942: UJC is housed at Grant School, called the "Old Lady of Holly Street," and rents the space from the Cranford Board of Education.
- 1944: To better accommodate returning veterans from WWII, the College creates a Veterans Study Center and changes the academic year from two semesters to one divided into four quarters.
- **1944:** Dr. Kenneth Campbell MacKay succeeds Dr. Cole as president.
- 1948: For less than \$56,000, the Board of Trustees authorizes the purchase of 56 acres from the Dreyer family in Cranford. A decade later it becomes the home of the Cranford Campus.
- 1949: Elizabeth General Hospital begins its affiliation with the College in the training of nurses. Later, Muhlenberg Hospital joins the partnership. Elizabeth General is now Trinitas School of Nursing and Muhlenberg Hospital Nursing School is now JFK Medical Center Muhlenberg Harold B. and Dorothy A. Snyder Schools. Both still operate cooperative programs with the College.
- 1958: A Development Fund
 Campaign is initiated on Oct.
 1 to raise \$1 million to build a
 Cranford Campus.
- 1959: The Nomahegan Building is completed in July and the College moves its operations to the 48-acre Campus in Cranford.

- **1967:** The word "Junior" is dropped and the College is officially known as Union College.
- 1968: Dr. MacKay steps down and is succeeded by Dr. Kenneth W. Iversen, who serves as president until 1974.
- **1970:** The College begins holding classes in Elizabeth at the Bayway Community Center and the Elizabeth YMCA on Aug. 5.
- **1970:** The College begins offering classes in Plainfield on Sept. 2.
- **1973:** The MacKay Library opens on the Cranford Campus.
- **1974:** Dr. Saul Orkin becomes president and serves until his death in 1983.
- **1977:** The women's basketball team is named the Region XIX Champions.
- 1982: Union College merges with the Union County Technical Institute and Union County College is established on Aug. 17.
- **1983:** Dr. Derek N. Nunney is named president.
- **1989:** The College acquires the Elizabethtown Gas Company building on West Jersey Street in Elizabeth.
- **1990:** Dr. Thomas H. Brown becomes president.
- 1991: The Campus Center, now known as the Victor M. Richel Student Commons, opens on the Cranford Campus.
- 1992: The College purchases the Courier News Building in Plainfield and begins offering courses in the newly renovated two-story building.

- 1992: The Elizabeth Campus opens on Sept. 1. The former Elizabethtown Gas Company building is named the Sidney F. Lessner Building.
- 1994: Renovations in the lower level of the MacKay Library in Cranford are completed in June and a state-of-the-art Visual Arts and Communications Center opens. The College partners with Rutgers (then the University of Medicine and Dentistry) and opens a Health Technologies Building in Scotch Plains to offer joint health professions programs.
- 1995: "The Pavilion" opens at the Cranford Campus with a new Fitness Center and the Executive Education Center.
- **1999:** The Annex Building is completed in Plainfield and houses instructional space for the American Sign Language and the Emergency Medical Technician/Paramedic programs.
- 2002: Trinitas School of Nursing moves to the Elizabeth Campus.
- **2007:** The Union County College Foundation finishes a capital campaign that raises \$8 million for capital construction and student scholarships.
- 2007: The Middle States Commission on Higher Education conducts a peer review and the College's accreditation was again reconfirmed.
- **2009:** Thanks to the support of the Union County Board of County Commissioners, the College opens the \$48 million Elizabeth I. Kellogg Building at 40 West Jersey Street in Elizabeth on Sept. 29.
- 2010: Dr. Margaret M. McMenamin, the College's eighth and first female president, begins her tenure on July 1.
- 2012: The Middle States Commission on Higher Education approves the College's Periodic Review Report by reaffirming the College's accreditation and commending the institution for the quality of the report and the process of the review.
- **2013:** The College revamps its mission statement to "Transforming Our Community... One Student at a Time," to accurately reflect the nature of the environment at the three campuses.
- **2014:** The first Winter Commencement Ceremony is held on Jan. 14 for August and December graduates.
- 2015: The new Health Sciences Building, the former Thul Auto Parts Building, opens at the Plainfield Campus on Oct. 20.

- 2016: After two years of construction, the Helen E. Ćhaney Student Services Center opens in the new two-story Student Development Building at the Cranford Campus. This project was made possible thanks to the support of the Union County Board of County Commissioners and the Union County Improvement Authority.
- 2016: The Annex at the Plainfield Campus reopens after damages caused by a 2012 fire and includes a new information commons, cafeteria, bookstore, and faculty offices.
- 2017: In March, the Middle States Commission on Higher Education Site Visit Team comes to the College for the official accreditation review. The College receives notification that the accreditation is reaffirmed in June.
- 2017: A Veterans Center is dedicated in the Helen E. Chaney Student Services Center at the Cranford Campus.
- 2018: A major renovation of the lower level and first floor of the Lessner Building at the Elizabeth Campus is completed.
- 2018: An Innovation Center is established at the Cranford Campus to provide students with the opportunity to learn current technologies such as coding, virtual reality, and using 3D printers.
- **2018:** Union is the first community college in New Jersey to receive a \$1.5 million grant from the National Science Foundation under the new Hispanic-Serving Institutions Program.
- 2018: The College publishes its first Undergraduate Research Journal and builds a Student Research Lab to provide dedicated space for ongoing research projects.
- 2019: Union establishes a respiratory care program at the Plainfield Campus.
- 2019: The College is named a Top 150 U.S. Community College by The Aspen Institute for the first time and is eligible to compete for the 2021 \$1 million Aspen Prize for Community College Excellence.
- 2019: Major renovations to the Health Sciences Building in Plainfield are completed.
- 2020: COVID-19 hits the U.S. and forces the College, and all educational institutions in New Jersey, to move operations and instruction remote during the Spring 2020 semester.
- **2020:** Operations return to campus in July. Fall classes are offered remote live,

- online, and face-to-face. Remote live courses are the most common mode of class offered in the fall semester to provide instruction in real time but by virtual means.
- 2020: Dr. McMenamin is named the Marie Y. Martin Community College CEO of the Year by the Association of Community College Trustees.
- **2021:** A major renovation of the Roy W. Smith Theater is completed.
- **2021:** Weidenburner Hall is dedicated in honor of a \$2.7 million donation by alumnus Bruce Weidenburner, which is the largest single donation in Union County College Foundation history.
- **2021:** For the second consecutive time, the College is named a Top 150 U.S. Community College by the Aspen Institute and is eligible to compete for the 2023 \$1 million Aspen Prize for Community College Excellence.
- **2022:** The College's Scotch Plains Campus is re-opened as a destination campus and re-imagined as a University Center and home to the College's virtual campus.
- **2022:** In April, the College is named as one of 25 semifinalists for the 2023 \$1 million Aspen Prize. Union is the only college in New Jersey to be named as a semifinalist.
- 2022: In May, Union hosts its first in-person Commencement in 2.5 years, since before the pandemic. It is also the first time in a decade the ceremony is held on the Cranford Campus.
- 2022: On July 1, Union County College changes its name to Union College of Union County, New Jersey.
- 2022: At the College's Founders Day Ceremony in October, the new logo is revealed to the Union community.
- 2023: eSports competitors were crowned the Champions of Overwatch 2 and Mario Kart in the National Junior Athletic Association (NJCAA) Competition, making this the first National Championship since the program was established in 2018.
- **2023:** For the first time, two Union students are selected for the Jack Kent Cooke Foundation Undergraduate Transfer Scholarship. Union now has had six graduates who have received this prestigious award.

October 16, 1933, when it was established as an emergency junior college. Ninety years, four campuses, and six name changes later, the College continues to grow and thrive. Whether a student is enrolling in a full-time degree program or is taking non-credit courses, Union's mission remains the same, "Transforming Our Community, One Student at a Time." Over the span of 90 years, Union has been twice named a top 150 community college in the country, named a top 25 community college in 2022, and has maintained its Middle States accreditation. Students have received life changing scholarships, been admitted to Ivy League universities all over the country, and have succeeded in various career fields. The Union community is eager to celebrate the past 90 years and looks forward to continuing its legacy for the next 90.
