Resolution E023-007 - STEM Articulation Agreement - Felician University

- WHEREAS, a STEM Articulation Agreement has been reached between Union College of Union County, New Jersey (Union) and Felician University (Felician), that establishes a cooperative academic relationship between the two institutions that enables students who graduate from Union with an associate degree in biology, computer science, cybersecurity, mathematics, or health science to obtain a baccalaureate degree in the respective major from Felician (Exhibit 1), and,
- NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of Union College of Union County, New Jersey approves the STEM Articulation Agreement between Union College of Union County, New Jersey (Union) and Felician University, School of Arts and Sciences (Felician) (Exhibit 1), and,
- **BE IT FURTHER RESOLVED** that College officials be authorized to approve the STEM Articulation Agreement between Union College of Union County, New Jersey (Union) and Felician University (Felician) (Exhibit 1).

On motion duly made by Mrs. Zimmermann, seconded by Dr. Tasharofi and unanimously carried, the Board approved the Resolution for adoption.

SAFETY REPORT

Dr. McMenamin stated that in compliance with N.J.S.A. 18A:3B-71 requiring reporting of campus crimes and fire incidents for the period from November 14, 2022 to January 3, 2023, Public Safety advised that there were no incidents to report.

BUDGET AND FINANCE COMMITTEE

Mr. Connolly stated that the Budget and Finance Committee met earlier and reviewed the Investment Report and reported that all investments are found to be in order and are within acceptable norms.

Mr. Connolly stated that Financial Report was also reviewed and reported revenue is up slightly due to an increase in credit hours of out-of-county students year over year, and the net increase in total expenses year over year is a result of timing of expenses and the increase in compensation, legal,

insurance and software costs. He stated that State funding is up \$470 thousand due to the new funding formula.

Current Estimate Report:

Mr. Connolly stated also reviewed was the Current Estimate Report and reported that at this time, a transfer to Unrestricted Net Position of \$2.7 million is anticipated for fiscal year ended June 30, 2023.

Resolution F023-018 Fiscal 2023-2024 Budget Adoption

- WHEREAS, the Board of Trustees of Union College of Union County, NJ is required to prepare and deliver to each member of the Union College of Union County, NJ Board of School Estimate "an itemized statement of the amount of money estimated to be necessary for the operations and capital outlay expenditures for the ensuing year," and
- **WHEREAS,** under the terms of the Higher Education Restructuring Act, a public hearing for the Union College of Union County, NJ community is being conducted "on the amount of money estimated to be necessary for the operations and capital outlay expenditures for the ensuing year."
- NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of Union College of Union County, NJ adopts the budget for FY 2023-24 totaling \$73,324,526 based upon a 5,958 State of New Jersey fundable full-time equivalent student enrollment, and
- **BE IT FURTHER RESOLVED** that the Union College of Union County, NJ Board of School Estimate be requested to certify to the Union County Board of County Commissioners that \$16,374,380 be appropriated for the operations of Union College of Union County, NJ for the period from July 1, 2023, to June 30, 2024, and
- **BE IT FURTHER RESOLVED** that a capital outlay budget for FY 2023-2024 totaling \$8,034,993 be adopted, and
- **BE IT FURTHER RESOLVED** that the Union College of Union County, NJ Board of School Estimate be requested to certify to the Union County Board of County Commissioners that \$8,034,993 be appropriated for capital outlay expenditures of Union College of Union County, NJ for FY 2023-2024, and
- **BE IT FURTHER RESOLVED** that a date, place, and time for the holding of public hearing by the Union College of Union County, NJ Board of School Estimate on the FY 2023-2024 budget be selected, and appropriate public notice be given pursuant to the applicable statutes.

On motion duly made by Mr. Connolly, seconded by Mr. Katz and unanimously carried, the Board approved the Resolution for adoption.

Resolution F023-019 - FY 2023-2024 Tuition Rates and Fee Adoption

WHEREAS, Chapter 42, P.L.L 1982 authorizes the Board of Trustees to "fix and determine tuition rates and other fees to be paid by students", and

WHEREAS, the following tuition rates and fee changes are reflected in the proposed budget for FY 2023-2024,

Resolution F023-020 College Readiness Now IX Grant

- **WHEREAS,** Union College of Union County, New Jersey, as a comprehensive community college, seeks to provide opportunities to increase college readiness of high school students prior to graduation, and
- WHEREAS, the College responded to an opportunity offered by the New Jersey Council of County Colleges (NJCCC) through a partnership with the New Jersey Office of the Secretary of Higher Education (OSHE). The program's priority is to identify students in the 9th through 12th grade, living below the poverty line who are not yet "college ready". Recipients of this grant are responsible for defining and documenting the methodology utilized to identify students who are living below the poverty line by using an assessment tool, and
- WHEREAS, Union College of Union County, New Jersey received notification from the New Jersey Council of County Colleges (NJCCC) that \$61,921 was approved for the College Readiness Now IX Grant for the period July 1, 2022 to June 30, 2023, and
- WHEREAS, the College will partner with Linden, Township of Union, and Plainfield Public Schools to recruit juniors and seniors for an online English 101 Accelerated Learning Program (ALP) and provide tuition for 60 students. Based on their self-placement questionnaire, students will co-enroll in a supplemental course in addition to enrolling in English 101 to bolster their reading or writing skills. There will be orientation and developmental workshops at the high schools to increase college knowledge and provide additional support to the students;
- NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of Union College of Union County, New Jersey accepts \$61,921 in funding from the New Jersey Office of the Secretary of Higher Education (OSHE) through the New Jersey Council of County Colleges (NJCCC) for the fiscal period July 1, 2022 to June 30, 2023 for the College Readiness Now IX Grant

On motion duly made by Mr. Connolly, seconded by Mr. Figueredo and unanimously carried, the Board approved the Resolution for adoption.

Resolution F023-021 Replacement of Submersible Pumps-Kellogg Building

WHEREAS, there is a need to install new submersible pumps at the Kellogg Building due to Hurricane Ida, in support of the mission of the College, and

- **WHEREAS**, County College Contracts Law, N.J.S.A. 18A:64A-25.9. provides that any purchase, contract, or agreement may be made, negotiated, or awarded without public advertising when there is an equipment repair service in the nature of an extraordinary unspecifiable service and necessary parts furnished in conjunction with that service, and
- **WHEREAS,** Universal Electric Motor Service, Inc., Hackensack, NJ has provided a proposal for the replacement for new submersible pumps at a cost not to exceed \$56,346 for the Kellogg Building, and
- **WHEREAS**, the College is applying to recoup this expenditure through a FEMA application as this is considered mitigation efforts and coverable under same, and
- **WHEREAS,** the New Jersey Local Unit Pay-to-Play Law, N.J.S.A. 19:44A-20.4. et seq. provides that when the values of all contracts to a single vendor exceeds \$17,500 in the aggregate, that vendor is subject to the Pay-to-Play Law, and
- **WHEREAS**, the Vice President of Finance and Operations has determined that the total contract award will exceed \$17,500, and
- WHEREAS, Universal Electric Motor Service, Inc., Hackensack, NJ has completed and submitted Business Entity Disclosure and Political Contribution Disclosure Certifications, certifying that they have not made any reportable contributions to a political or candidate committee in the previous one year, and that they will be prohibited from making any reportable contributions through the term of the contract, and
- **WHEREAS**, a Certification of Funds availability has been filed by the Vice President of Finance and Operations;
- NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of Union College of Union County, New Jersey award a contract to Universal Electric Motor Service, Inc., Hackensack, NJ for replacement of submersible pumps at the Kellogg Building at a cost not to exceed \$56,346 for Fiscal Year 2022-2023.

Resolution F023-022 Building HVAC Management Control Systems Maintenance Services

- **WHEREAS,** the College requires maintenance, repair services, testing, and inspections of the computerized heating, ventilation, and air conditioning (HVAC) management control systems on all campuses, in support of the mission of the College, and
- **WHEREAS,** the County College Contracts Law, N.J.S.A. 18A:64A-25.11a. provides for awarding contracts without public competitive bids when there is a state recognized and accepted cooperative agreement for the product or service that has been publicly bid, and

- WHEREAS, A.M.E. Inc., Fairfield, NJ has submitted a proposal under Educational Services Cooperative of New Jersey (ESCNJ) Co-op # ESCNJ 20/21-50 to provide building HVAC management control systems maintenance services on all campuses from January 2023 until June 30, 2023 for an award not to exceed \$43,850, and
- **WHEREAS,** the approximate cost for twelve (12) months for HVAC management control services for all campuses was \$71,750, and
- **WHEREAS,** the New Jersey Local Unit Pay-to-Play Law, N.J.S.A. 19:44A-20.4. et seq. provides that when the values of all contracts to a single vendor exceeds \$17,500 in the aggregate, that vendor is subject to the Pay-to-Play Law, and
- **WHEREAS,** the Vice President of Finance and Operations has determined that the total contract award will exceed \$17,500, and
- **WHEREAS,** ESCNJ utilized competitive bidding for the award of the contracts to A.M.E Inc., Fairfield, NJ thereby releasing Union College of Union County, New Jersey from the requirement to obtain Pay-to-Play documentation, and
- **WHEREAS**, a Certification of Funds availability has been filed by the Vice President of Finance and Operations;
- **NOW, THEREFORE, BE IT RESOLVED** that the Board of Trustees of Union College of Union County, New Jersey award a contract to A.M.E Inc., Fairfield, NJ to provide building HVAC management control systems maintenance services on all campuses at a cost not to exceed \$43,850 from January 2023 until June 30, 2023.

Resolution F023-023 Digital Subscription Services

- **WHEREAS,** there is a college-wide need for greater affordability of course and learning materials, in support of the mission of the College, and
- **WHEREAS,** the County College Contracts Law, N.J.S.A. 18A:64A-25.5.a.(6) provides for exceptions to the requirements for advertising for bids for purchase of copyrighted materials, library books, magazines and periodicals and specialized library services, and
- **WHEREAS,** the County College Contracts Law, N.J.S.A. 18A:64A-25.5.a.(21) provides for exceptions to the requirements for advertising for bids for purchase of educational supplies, books, articles of clothing and other miscellaneous articles purchased by a county college bookstore, or by a service or management company under contract with a county college to operate a county college bookstore for resale to college students and employees, and

- **WHEREAS,** Cengage Learning, Inc., Stamford, CT has submitted a proposal at a flat fee of \$134.00 per activated subscription per year, for access to over 20,000 digital learning materials, and
- WHEREAS, under the terms of the contract that runs from March 1, 2023 until February 28, 2025, the College, through the Follett bookstore, would purchase a minimum of \$804,000 annually in Cengage Unlimited subscriptions, for a total contract amount not to exceed \$1,608,000, and
- **WHEREAS**, the cost for digital subscription services for the previous two (2) fiscal years was a flat fee of \$130.00 per year per activated subscription, and
- **WHEREAS,** the New Jersey Local Unit Pay-to-Play Law, N.J.S.A. 19:44A-20.4. et seq. provides that when the values of all contracts to a single vendor exceeds \$17,500 in the aggregate, that vendor is subject to the Pay-to-Play Law, and
- **WHEREAS**, the Vice President of Finance and Operations has determined that the total contract award will exceed \$17,500, and
- WHEREAS, Cengage Learning, Inc., Stamford, CT has completed and submitted their Business Entity Disclosure and Political Contribution Disclosure Certifications that certify they have not made any reportable contributions to a political or candidate committee in the one year previous to their contract award, and the contract will prohibit Cengage Learning, Inc., Stamford, CT from making any reportable contributions through the term of their contracts, and
- **WHEREAS**, a Certification of Funds availability has been filed by the Vice President of Finance and Operations;
- **NOW, THEREFORE, BE IT RESOLVED** that the Board of Trustees of Union College of Union County, New Jersey award a contract for digital subscription services starting on March 1, 2023 until February 28, 2025 to Cengage Learning, Inc., Stamford, CT for a total cost not to exceed \$1,608,000.

Resolution F023-024 Entrepreneurial Training Program

- **WHEREAS**, there is a need to design an entrepreneurial training program, in support of the mission of the College, and
- WHEREAS, on September 21, 2021 the Board of Trustees accepted \$998,000 from the State of New Jersey, Office of the Secretary of Higher Education for the Governor's Emergency Education Relief Fund II (GEERF II) Grant through the Opportunity Meets Innovation Challenge (OMIC) of which \$468,900 in funds was earmarked for "Research Innovation and Talent" development for the period June 1, 2021 through September 30, 2023, and

- **WHEREAS,** the County College Contracts Law, N.J.S.A. 18A:64A-25.11.a. provides for awarding contracts without public competitive bids when there is a state recognized and accepted cooperative agreement for the product or service that has been publicly bid, and
- **WHEREAS,** the County College Contracts Law, N.J.S.A. 18A:64A-25.5.a.(15) provides for an exception to the requirement for advertising for bids for professional consulting services, and
- **WHEREAS**, the County College Contracts Law, N.J.S.A. 18A:64A-25.5.a.(19) provides for an exception to the requirement of advertising for bids in the provision of goods or services for the use, support or maintenance of proprietary computer hardware, software peripherals and system development for the hardware, and
- WHEREAS, Qunnections Management Group, LLC., Newark, NJ, and SHI International, Somerset, NJ have submitted proposals as follows that will be used for the design of an entrepreneurial training program:

- WHEREAS, on January 12, 2023, Union College of Union County, New Jersey (the "College") submitted a preliminary request to the New Jersey Council of County Colleges ("NJCCC") for capital funding under N.J.S.A. 18A:72A-12.4. County College Capital Projects Funding ("Chapter 12"), and
- **WHEREAS,** NJCCC has advised the College of its pending recommendation to the State Treasurer that preliminarily would make available \$4.149 million to the College under Chapter 12 funding, and
- **WHEREAS**, the funds will be used to renovate the physical education facility on the Cranford campus, and
- WHEREAS, the total cost of the project is estimated to be \$20 million, and
- WHEREAS, on February 25, 2020, the Union County College Board of Trustees authorized renovations to the Cranford Campus Physical Education Facility Renovation and certified an amount of money for such purpose as \$5.580 million to be provided under the provisions of the fiscal year 2021 Chapter 12 funding, and
- WHEREAS, on February 23, 2021, the Union County College Board of Trustees authorized renovations to the Cranford Campus Physical Education Facility Renovation and certified an amount of money for such purpose as \$5.578 million to be provided under the provisions of the fiscal year 2022 Chapter 12 funding, and
- WHEREAS, on February 22, 2022, the Union County College Board of Trustees authorized renovations to the Cranford Campus Physical Education Facility Renovation and certified an amount of money for such purpose as \$4.264 million to be provided under the provisions of the fiscal year 2023 Chapter 12 funding, and
- WHEREAS, Union College of Union County, New Jersey has an interest in pursuing funds that may be available under the provisions of Chapter 12 for financial assistance in connection with this project and accordingly has included it in its preliminary request to the NJCCC for fiscal year 2024 Chapter 12 funding, and
- **WHEREAS,** pursuant to N.J.S.A. 18A:64A-19, the Union College of Union County, New Jersey Board of Trustees is to deliver to the Union College of Union County, New Jersey Board of School Estimate (the "Board of School Estimate") an estimate of its cost of the project and the amount of money needed for the project;

- NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of Union College of Union County, New Jersey hereby determines a) the need for the College to expend \$20 million for a renovated physical education facility on the Cranford campus, and b) the estimated cost of this construction is \$20 million, c) the amount of money needed for such purpose by the Board of Trustees of the College is \$20 million, and d) the College will pursue Chapter 12 State funding for all or a portion of said purpose.
- **BE IT FURTHER RESOLVED** that The Board of School Estimate is hereby requested to certify to the Union County Board of County Commissioners that \$4.149 million be raised through the issuance of County College bonds and notes by the County of Union to fund the renovated physical education facility on the Cranford campus.
- **BE IT FURTHER RESOLVED** that a copy of this resolution shall be delivered to each member of the Union College of Union County, New Jersey Board of School Estimate.

On motion duly made by Mr. Katz, seconded by Mr. Figueredo and unanimously carried, the Board approved the Resolution for adoption.

NEW BUSINESS

Mr. Richel named Mr. Katz to serve on the Board of Trustees Nomination Committee in place of Mr. Bashe, who resigned from the Board of Trustees last month. He stated that the Committee consists of Mrs. Zimmermann as Chair, Mr. Katz, and Mr. Betancourt.

EXECUTIVE SESSION

Mr. Katz read the following Resolution:

<u>Resolution PT023-001 - Resolution Authorizing a Closed Session of the Board of Trustees of Union College of Union County, NJ</u>

- **WHEREAS**, the Board of Trustees of Union College of Union County, NJ are subject to New Jersey's Open Public Meetings Act; and
- **WHEREAS,** the Open Public Meetings Act generally requires that all meetings of public bodies be open to the public but that the public may be excluded from a portion of a meeting at which items requiring confidentiality are to be discussed as enumerated in N.J.S.A. 10:4-12b; and

NOW, THEREFORE BE IT RESOLVED by the Board of Trustees of Union College, pursuant to the Open Public Meetings Act that:

- 1. The Board of Trustees of Union College shall hold a closed meeting on January 17, 2023 from which the public shall be excluded.
- 2. The Executive Session will convene at approximately 6:50 p.m. and is expected to last until approximately 7:10 p.m.

The meeting went into Executive Session and the meeting resumed at 7:25 p.m.

Mr. Katz read the following Resolution:

Resolution BT023-001 - Authorization for Retention Stipends

- **WHEREAS,** the College values its employees and is committed to supporting and retaining the current talented workforce, in support of the mission of the College, and
- **WHEREAS**, over the past several years the College has experienced talent drain and a loss of our rising leaders, people who were cultivated, developed and trained, to competing institutions and other businesses, and
- **WHEREAS**, the retention stipends are for full-time bargaining unit members with annual salaries of \$85,000 and under AND all non-aligned full-time employees.

WHEREAS, the criteria for participation is follows:

- Eligible employees must be hired on or before July 1, 2022.
- Eligible employees need to be active on the payroll at the time of processing. Any employees with future termination dates are not eligible.
- The retention stipend may not exceed \$5,000.00.

WHEREAS, the Vice President of Finance and Operations certifies that sufficient funds are available from the Emergency Employee Relief Fund, and

NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of Union College of Union County, New Jersey authorize Retention Stipends, as described above, for an amount not to exceed \$355,000 to be paid in FY 2023.

On motion duly made by Mr. Katz, seconded by Dr. Tasharofi and unanimously carried, the Board approved the Resolution for adoption
