Dr. Segal read the following statement: Pursuant to New Jersey Statutes Annotated 10:4-6, revised notice of this regular meeting of the UCNJ Board of Trustees was transmitted to the Star Ledger, Newark and Courier News, Somerville, which specified time and place of this meeting as Tuesday, June 17, 2025 at 5:30 p.m. in the Executive Education Center on the Cranford Campus. In addition, adequate revised notice was also posted at the Union County Courthouse, Elizabeth, N.J., and the College's campuses in Cranford, Elizabeth, Plainfield, and Scotch Plains and on the College's website at www.ucc.edu.

A quorum of the Board of Trustees was present.

MINUTES

On motion duly made by Mr. Betancourt and seconded by Ms. Mehrotra, the Minutes of the Meeting of the Board of Trustees of May 6, 2025 were approved as submitted.

COMMUNICATIONS

There were no communications to report. Mr. Richel recognized Dr. Segal for being named a 2025 Union County Shero. He also acknowledged Mrs. Zimmermann's tenure as former Chair of Governors of the College. She will still remain on the Board of Governors.

REPORT OF THE PRESIDENT

Dr. McMenamin addressed the members of the Board highlighting some of the events that are currently taking place at the College:

- UCNJ held its 2025 Commencement Ceremony on the Cranford Campus where more than 700 students received their degrees.
- UCNJ student Odudu Ekpenyong was awarded the Jack Kent Cooke Foundation's Undergraduate Transfer Scholarship. He will receive as much as \$55,00 a year to complete his bachelor's degree. Odudu plans to pursue a degree in aviation science with a concentration on professional piloting.
- The Union County College Foundation has awarded the Margolies Family Transfer Scholarship this year to Lucas Dasilva and Rachel Sweet. They will receive up to \$25,000 in transfer funds for two years.
- The College celebrated 17 graduates from the Practical Nursing Program.
- Eleven UCNJ students will attend Princeton University's Transfer Scholars Initiative (TSI). This program allows community college students to enroll in a full time, eightweek academic curriculum.
- UCNJ attended the Hispanic Association of Colleges and Universities (HACU) 30th Capitol Forum held in Washington, DC.
- The College celebrated more than 30 Academic Learning Center (ALC) tutors who graduated this spring. The ALC also celebrated its 40th Anniversary of providing students with free peer tutoring across all campuses.
- Dr. Jaime Segal, AVP of External Affairs & Board Secretary, was recognized as a 2025 Union County Shero.

Dr. McMenamin stated that this evening we will kick off our Board and Staff Leadership Retreat with many great guest speakers. She concluded by stating that we had a wonderful year and she thanked the Boards for their support.

Dr. Polnariev provided a year-end summary of the highlights of the Academic Year 2024-25 as provided by Dr. Lown, Dr. Hargrove, Dr. Lacagnino, and Chief Financial Officer, Ms. Sousa.

Resolution E025-019 - Non-Aligned Staff Salary Increases

- **WHEREAS**, the Board recognizes the contributions and service of the full-time managerial and confidential employees of the college, and it is the intention of the Board to provide salary increases to eligible personnel and,
- **NOW, THEREFORE, BE IT RESOLVED** upon recommendation of the President that a salary increase pool equal to 4.5% of the aggregate total base salaries of all full-time managerial and confidential personnel shall be established, with individual salary increases to be determined at the discretion of management and,
- **BE IT FURTHER RESOLVED** those increases shall apply only to employees on the payroll as of July 1, 2025, and who were hired on or before March 31, 2025. Employees hired between January 1 and March 31, 2025, shall receive prorated increases based on their date of hire.

On motion duly made by Mr. Castro, seconded by Ms. Mehrotra and unanimously carried, the Board approved the Resolution for adoption.

Resolution E025-020 - College Policies

WHEREAS, UCNJ Union College of Union County, NJ, as a comprehensive community college, has college-wide policies to ensure compliance with policy objectives and accountability, and

WHEREAS, a College policy is a prescribed institutional course of action, a guiding principle, or a procedure intended to enhance strategic goals; reduce institutional risks; improve internal controls; establish delegation of authority and responsibility; promote compliance with federal, state and other applicable laws and regulations; further operational alignment, consistency, or efficiency; and/or influence and determine decisions, actions, conduct, and other matters at the College, and

- **WHEREAS**, the College's Policy on Policies sets forth that the Board of Trustees or the President serve as the "Approval Authority" for College-wide policies, and
- NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of UCNJ Union College of Union County, NJ approves the revisions to the following policies attached as Exhibit 1: 200-19 Second Degrees Policy, 200-21 Transfer Credit Policy, 300-26 Tuition Refund Policy, 300-27 Residency Policy, 300-34 Smoke Free Policy, and 400-3 Refund Policy.

On motion duly made by Mr. Castro, seconded by Ms. Mehrotra and unanimously carried, the Board approved the Resolution for adoption.

SAFETY REPORT

Dr. McMenamin stated that in compliance with the Cunningham – Ruiz Law (S485, codified at N.J.S.A. 18a:3B-71) requiring reporting of campus crimes and fire incidents for the period from April 9, 2025 through May 27, 2025, Public Safety advised that there was a report of suspected fraudulent activity on one the Union County College Foundation's financial accounts. He stated that this matter is being investigated by the Cranford Police Department as a possible crime. There are no other issues to report.

BUDGET AND FINANCE COMMITTEE

Investment Report:

Mr. Campbell stated that the Budget and Finance Committee met earlier and reported that all investments are found to be in order and are within acceptable norms.

Financial Report:

Mr. Campbell reviewed the Financial Report and reported that variances within the report are due to the following:

- An increase in enrollment which impacted tuition revenue and student receivable;
- The timing of a payable for health benefits. By comparison, the corresponding FY2024 payment was made in March 2024;
- The net increase in expenses, primarily driven by the various contract negotiations, rising healthcare premium, utilities and the addition of new software.

Current Estimate Report:

Mr. Campbell reviewed the Current Estimate Report and stated that at this time, a transfer from Unrestricted Net Position of \$4.2 million is anticipated for fiscal year ended June 30, 2025:

Mr. Campbell provided a report of executed contracts with the County of Union which included: Workfirst New Jersey-Supplemental Nutrition to Needy Families (7/1/24 – 6/30/25; NJDOL; \$100,000; GA/Snap services), Workfirst New Jersey-Temporary Assistance to Needy Families (7/1/24 – 6/30/25; NJDOL; \$200,000; TANF services), and Workforce Learning Link (7/1/24 – 12/31/24; NJDOL; \$60,000; literacy training).

Grant Resolutions

Resolution F025-063 - Authorization to Obligate Carl D. Perkins Grant Fiscal Year 2025-2026 Funding

- WHEREAS, UCNJ Union College of Union County, NJ as a comprehensive community college, seeks to provide career occupational training programs to prepare UCNJ students and other Union County residents for employment, and
- WHEREAS, the Carl D. Perkins Strengthening Career and Technical Education for the 21st Century Grant ("Perkins Grant") is a federally authorized grant whose aim is to increase the academic achievement of career and technical education students and strengthen the connections of secondary and post-secondary education, and
- WHEREAS, on June 10, 2025, the State of New Jersey Department of Education ("NJDOE") notified the College of its preliminary allocation of \$1,093,362 under the Perkins Grant for Fiscal Year 2025-2026, and
- **WHEREAS**, the College will file its Fiscal Year 2025-2026 application and spending plan based on the allocation with the NJDOE in the amount of \$1,093,362, principally covering instructional equipment, related materials and supplies, software and licenses, testing materials, and other costs, and
- **WHEREAS,** notification from the NJDOE that the College's application and spending plan are in "substantially approvable form" typically is received by the College several months into the grant year, and
- WHEREAS, the NJDOE will require that equipment expenditure items contained within the Fiscal Year 2025-2026 spending plan be received, installed, and available for student instruction typically by April 30, 2026, and the resulting period to procure, receive and utilize the Perkins funded expenditures is subject to the long lead times inherent in the mandatory procurement and authorization efforts that are in compliance with the County College Contracts Law and related laws and regulations resulting in the possibility to fully utilize the entirety of the Perkins allocation, and
- **WHEREAS,** the College has sufficient financial reserves to absorb any portion of Perkins obligated expenditures that are not ultimately found to be in "substantially approvable form" by the NJDOE;

NOW, THERFORE, BE IT RESOLVED that the Board of Trustees of UCNJ Union College of Union County, NJ hereby authorizes the College to obligate Carl D. Perkins Strengthening Career and Technical Education for the 21st Century Grant ("Perkins Grant") in advance of the Board accepting the funding as to fully utilize Perkins Program funding during Fiscal Year 2025-2026 to the fullest extent possible.

Resolution F025-064 - Authorization to Obligate Community College Opportunity Grant (CCOG) Funding

- **WHEREAS,** UCNJ Union College of Union County, NJ is a comprehensive community college providing quality, affordable, accessible educational programs that serve the greater Union County region, and
- **WHEREAS,** the Community College Opportunity Grant (CCOG) is the State of New Jersey's community college initiative that started as a pilot program in Fiscal Year 2019 to provide last dollar awards to New Jersey resident, community college students, for the opportunity to obtain a college education, and
- **WHEREAS,** on February 26, 2021, the Governor signed Bill A4410 which permanently established this grant program which runs from July 1st of each year through June 30th, and
- WHEREAS, the grant is awarded through the State of New Jersey, Office of the Secretary of Higher Education (OSHE) and the purpose of the partnership with the College is to increase matriculation and support the goals of the Community College Opportunity Grant by implementing goals and strategies for capacity building and increasing enrollment, improving student completion, and reducing financial burdens on students, and
- WHEREAS, the College's funding amount for Fiscal Year 2025 was \$376,569 and notification of this year's allocation and contract from the State of New Jersey Office of the Secretary of Higher Education (OSHE) is expected to be received this summer, and
- **WHEREAS**, the College has sufficient financial reserves to absorb any portion of the Community College Opportunity Grant funding obligated expenditures that are encumbered prior to the Fiscal Year 2026 contract being received;
- **NOW, THEREFORE, BE IT RESOLVED** that the Board of Trustees of UCNJ Union College of Union County, NJ hereby authorizes the College to obligate the Community College Opportunity Grant Funding in advance of the Board accepting the funds as to fully utilize the funding during Fiscal Year 2026 to the fullest extent possible.

Resolution F025-065 - Acceptance of Community College Opportunity Grant (CCOG) Additional Funding

- **WHEREAS,** UCNJ Union College of Union County, NJ, is a comprehensive community college providing quality, affordable, accessible educational programs that serve the greater Union County region, and
- WHEREAS, UCNJ Union College of Union County, NJ was notified that it was awarded \$376,569 for the Community College Opportunity Grant (CCOG) Student Success Initiative funding to be implemented during the period July 1, 2024, through June 30, 2025, by the State of New Jersey, Office of the Secretary of Higher Education (OSHE) and the Board of Trustees accepted the funding at the November 4, 2024 board meeting, and
- WHEREAS, the purpose of the partnership between the Office of the Secretary of Higher Education (OSHE) and the College is to increase matriculation and support the goals of the Community College Opportunity Grant (CCOG) by implementing goals and strategies for capacity building, increasing enrollment, improving student completion, and reducing financial burdens on students, and
- WHEREAS, on April 16, 2025, the College was offered the opportunity to apply for additional Community College Opportunity Grant (CCOG) funding for Fiscal Year 2025, and on May 9, 2025, the College received notification that its application was approved, and,
- **WHEREAS**, the College was awarded \$18,846 to further support the CCOG initiative with an extension of time for grant spending through September 30, 2025;
- NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of UCNJ Union College of Union County, NJ accepts the additional Fiscal Year 2025 funding of \$18,846 from the State of New Jersey, Office of the Secretary of Higher Education (OSHE) for the Community College Opportunity Grant (CCOG) Student Success for total award of \$395,415 for Fiscal Year 2025.

Resolution F025-066 - Authorization to Obligate County College Based Center for Adult Transition Grant Funding

- WHEREAS, UCNJ Union College of Union County, NJ as a comprehensive community college, seeks to enhance the lives of individuals with intellectual and developmental disabilities by providing transitional services, peer mentoring, educational opportunities, career exploration, and linkage to community services, and
- WHEREAS, the College applied to the State of New Jersey, Office of the Secretary of Higher Education ("OSHE") for the County College Based Center for Adult Transition Grant to provide students up to the age of twenty-four, who have developmental disabilities, the support and resources necessary to experience more successful transitions from secondary school to postsecondary education and adult

- employment, and promote independent living opportunities by providing appropriate skills to be successful, and
- WHEREAS, the Center supports the educational mission of UCNJ Union College of Union County, NJ by creating an inclusive community that meets the diverse needs of students through advocacy, equitable access, support, and resources, and
- **WHEREAS,** the College engages a cohort of students, who are able to administer their own medication, if applicable, have the capability to attend to their personal hygiene, have a strong desire to become an independent adult, and possess sufficient emotional stability to participate successfully, and
- WHEREAS, the College's funding amount for Fiscal Year 2025 was \$202,570, and
- **WHEREAS,** notice of this year's allocation and contract from the State of New Jersey, Office of the Secretary of Higher Education (OSHE) is expected to be received this summer, and
- **WHEREAS,** the College has sufficient financial reserves to absorb any portion of the County College Center for Adult Transition Grant funding obligated expenditures that are encumbered prior to the contract being received;
- NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of UCNJ Union College of Union County, NJ hereby authorizes the College to obligate the County College Center for Adult Transition Grant funding in advance of the Board accepting the funds so as to fully utilize the funding during Fiscal Year 2026 to the fullest extent possible.

Resolution F025-067 - Displaced Homemaker Program Renewal

- WHEREAS, UCNJ Union College of Union County, NJ as a comprehensive community college, seeks to provide career occupational training programs designed to assist displaced homemakers and domestic violence victims in Union County, and
- **WHEREAS,** on May 16, 2025, the College received notification from the State of New Jersey Department of Children and Families that the Displaced Homemaker Program has been renewed for Fiscal Year 2026, and
- WHEREAS, the College will continue to provide job counseling and other supportive services for women of Union County through the Displaced Homemaker Program which provides expanded services with a priority to educational training to displaced homemakers who have been dependent on the income of another household member, which has been lost due to hardships such as death or disablement of a spouse, separation, or divorce, and
- **WHEREAS,** the College is expected to service 90 clients during the duration of this program by assisting qualified individuals to successfully complete a short term program

- that will lead to future employment, and
- **WHEREAS,** the College will provide the required documentation to the State of New Jersey, Department of Children and Families required by the Displaced Homemaker Program;
- NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of UCNJ Union College of Union County NJ will accept \$169,999 for displaced homemakers and \$11,899 for domestic violence victims from the State of New Jersey Department of Children and Families for the renewal of the Displaced Homemaker Program for a total award of \$181,898 allocated for Fiscal Year 2026.

Resolution F025-068 - Acceptance of Opportunity Partnership Grant Funding

- **WHEREAS,** UCNJ Union College of Union County, NJ as a comprehensive community college, seeks to provide career occupational training programs designed to assist qualified Union County unemployed workers to create a pathway to employment, and
- WHEREAS, the College applied for the Opportunity Partnership Grant through the State of New Jersey, Department of Labor and Workforce Development to provide training opportunities within the state's predetermined targeted industry sectors, and
- **WHEREAS,** UCNJ Union College of Union County, NJ has proposed to coordinate a curriculum that provides occupational training for the Certified Medical Assistant occupation, which is in high demand in Union County, and
- **WHEREAS,** the College will work in collaboration with the One Stop Career Center (OSCC) liaison to recruit trainees for employment opportunities in this field, and
- WHEREAS, the total training plan consists of 508 classroom instructional hours and optional 112 externship hours of full-time training to 20 to 30 qualified participants who have received job counseling, and an Employability Development Plan (EDP) developed by a New Jersey Department of Labor designated One-Stop Career Center (OSCC) qualified job counselor who indicates the candidate is approved to receive training, and
- WHEREAS, on June 2, 2025, UCNJ Union College of Union County, NJ received notification from the State of New Jersey, Department of Labor and Workforce Development that funding in the amount of \$187,509 has been approved for the period June 9, 2025 through June 8, 2026;
- **NOW, THEREFORE, BE IT RESOLVED** that the Board of Trustees of UCNJ Union College of Union County, NJ accepts \$187,509 from the State of New Jersey, Department of Labor and Workforce Development for the period June 9, 2025 through June 8, 2026 for the Opportunity Partnership Grant.

Resolution F025-069 - Authorization to Obligate ABLE PLUS Consortium Grant Funding

- WHEREAS, UCNJ Union College of Union County, NJ as a comprehensive community college, seeks to provide career occupational training programs designed to assist College students and other Union County residents to become employed, and
- WHEREAS, the College applied, as the lead agency of the WIOA Title II, ABLE PLUS Consortium, to the State of New Jersey Department of Labor and Workforce Development (the "Department") for funding under the Workforce Investment Act of 1998, Title II, the Adult Education and Family Literacy Act for a competitive five-year annual renewable contract for Fiscal Years 2026 through 2030, and
- WHEREAS, the College has been the lead agency of the WIOA Title II, ABLE PLUS Consortium since 2001 with expansion of the program in 2005, and
- WHEREAS, notification from the State of New Jersey Department of Labor and Workforce Development informing the College that the application and proposed budget have been approved typically is received by the College two to three months after it receives the initial Notice of Award (NOA), and
- WHEREAS, the resulting approximate two to three month period to receive, procure, and utilize the ABLE PLUS Consortium Grant Funding for the College and its Consortium partners would be subject to personnel displacement and long lead times inherent in the mandatory procurement and authorization efforts in compliance with the County College Contracts Law and related laws which could result in the inability to fully utilize the entirety of the ABLE PLUS Consortium Grant funding, and
- WHEREAS, the College has sufficient financial reserves to absorb any portion of ABLE PLUS Consortium Grant Funding obligated expenditures that are not ultimately approved by the State of New Jersey Department of Labor and Workforce Development;
- NOW, THERFORE, BE IT RESOLVED that the Board of Trustees of UCNJ Union College of Union County, NJ hereby authorizes the College to obligate the ABLE PLUS Consortium Grant Funding in advance of the Board accepting the funds for the College and its Consortium partners to fully utilize the funding during Fiscal Year 2026 to the fullest extent possible.

Resolution F025-070 - Acceptance of the County of Union Workforce Innovation and Opportunity Act Additional Funding

WHEREAS, UCNJ Union College of Union County, NJ, as a comprehensive community college, seeks to provide career occupational training programs designed to assist adult and dislocated workers with employment and training activities for eligible residents of the County of Union and support the development of a strong globally competitive labor force, targeting key growth sectors within New Jersey, and

- WHEREAS, the College applied to the County of Union for Workforce Innovation and Opportunity Act (WIOA) funding to coordinate the Workforce Innovation Business Center (WIBC) to operate as an American Job Center Affiliate (AJCA) Career Service Center to provide job search, training, and job development services to eligible residents of the County to meet the needs of business by supporting local businesses and organizations in their recruitment of employees according to grant requirements, and
- WHEREAS, local employers leveraged the resources of the College's occupational and workforce initiatives which are carried out through the College's Center for Economic and Workforce Development (CEWD), the Industry Business Institute (IBI), and the Department of Continuing Education, and
- **WHEREAS,** an agreement was proposed by the County of Union whereby the College would take the lead on providing training that will support employers in health care, life sciences, financial services, advanced manufacturing, transportation, logistics and distribution, technology, entrepreneurship, retail, hospitality and tourism, and
- **WHEREAS,** the College was selected by the County as the grant recipient and administrative entity for Workforce Innovation and Opportunity Act (WIOA) funding, and
- **WHEREAS**, the College received notification on June 19, 2024, that funding in the amount of \$500,000 was awarded for the period June 1, 2024, to June 1, 2025, which was accepted by the Board of Trustees on September 17, 2024, and
- **WHEREAS**, the College was notified on May 30, 2025 that it was awarded additional funding of \$140,000 with an extension of time through September 30, 2025;

Mr. Katz reported on the updates to the Project Prioritization List as well as the various projects on all campuses.

Mr. Katz reported that at the May 8th meeting of the Cranford Planning Zone a number of Cranford residents attended and voiced their concerns regarding flooding. He stated that the area formerly known as the Athletic Field will now be the site of flood remediation.

Mr. Katz reported that the gymnasium will provide approximately 3,000 seats which will allow the College to hold its commencement ceremonies. He stated it will also allow for scheduling of credit and non-credit programs. Mr. Katz also provided an approximate timeline for the Physical Education Center (PEC): June 19 – bid package finalized; June 26 – vendor walk thru of the facility; August 19 – bids due.

Mr. Katz provided an update regarding the solar panels. He stated that the UCIA has provided the College with two options: the College could purchase the solar panels for \$1.00; the UCIA could remove of the solar panels and any damages would be the responsibility of the UCIA. All decisions must be made by September 1, 2025.

Kellogg Recovery Status:

Mr. Katz reported that the project is complete, however still working with FEMA regarding recovery.

Cell Tower Update:

Mr. Katz reported that several vendors on behalf of Verizon were on site doing engineering layouts where the cell tower will be located
