REPORT OF THE PRESIDENT

Dr. McMenamin addressed the members of the Boards highlighting some of the events that have taken place at the College over the past month:

• UCNJ was named as one of only 10 finalists for the 2025 Aspen Prize for Community College Excellence.

- UCNJ celebrated more than 700 graduates for the Class of 2024 on the Cranford Campus with two ceremonies.
- Four members of the UCNJ community received awards from the New Jersey Council of County Colleges at their Community College Opportunity Summit in Atlantic City. Board of Governors Chair and Board of Trustees member Mary M. Zimmermann received the Ronald D. Winthers Trustee Leadership Award; Vice President for Student Development Dr. Demon Hargrove received the Dr. Lawrence A. Nespoli Leadership Award; Associate Professor of Chemistry Sherry Heidary received the Distinguished Faculty Award; UCNJ Class of 2024 graduate Katherine Mejia received the New Jersey Student of the Year Award.
- UCNJ scholar-athlete Patrick Murray won the National Junior College Athletic Association Region XIX Golf Championship.
- UCNJ Class of 2024 graduate, Precious Opaola, has been accepted into Princeton University for fall 2024.
- The Union County College Foundation has launched the Margolies Family Transfer Scholarship which offers up to \$25,000 in transfer funds over two years. Myrvens Sylvestre, a computer science major, is the first recipient of this scholarship.
- Provost & Vice President for Academic Affairs Dr. Maris Lown Assistant Dean of Students, Beatriz Rodriguez, and UCNJ students Jeremy Albujar, Marisol Ramos, and Samir Perez represented UCNJ at the Hispanic Association of Colleges and Universities in Salamanca, Spain.
- More than 100 students completed their studies with the Institute of Intensive English followed by a reception.
- UCNJ's Iota Xi Chapter of PTK, the international honor society for two-year colleges, hosted its new member ceremony for the 232 new members.
- The Admissions Team, in partnership with the Community College Opportunity Grant hosted an open house on the Cranford Campus where almost 400 guests attended,

Dr. McMenamin congratulated the Board of Trustees and Governors stating that they should be proud to be board members for one of the top ten community colleges in the nation. She continued that the board should never underestimate the importance of their work because it matters to us, the leadership.

Dr. McMenamin stated that we are in the preparation phase for the visit from the Aspen team that will occur in October. She stated that although it would be nice to receive the prize, we do not do what we do to earn a prize; we do it to help our students earn a college degree and help them and their families on a path for social and economic mobility.

Dr. McMenamin stated that we became a top ten Aspen finalist because our faculty care about our students and are willing to put in the extra work to help our students get across the finish line. She concluded by stating that the people around this room have done the hard work to get to where we are today and this Board has supported them along the way.

WHEREAS, the need exists for a college-wide Independent Auditor, and

- **WHEREAS,** the County College Contracts Law, N.J.S.A. 18A:64A-25.5.a.(1) provides an exception to the requirement of advertising for bids for professional services, and
- WHEREAS, CliftonLarsonAllen LLP, Plymouth Meeting, PA submitted a proposal to provide independent auditing services of the College's Financial Statements, including Schedules of Expenditures of Federal Awards, and State Financial Assistance, conducted in accordance with Government Auditing Standards issued by the Comptroller General of the United States and in compliance with audit requirements as prescribed by the Department of Treasury, State of New Jersey; performing "agreed-upon procedures," developed by the New Jersey Council of County Colleges for use by the New Jersey Department of Treasury, upon the reporting requirements for fundable credit hours; and preparing a report on internal controls over financial reporting and such other matter as may be necessary for Fiscal Years 2023-2024 and 2024-2025 at \$72,000 for each Fiscal Year, and
- **WHEREAS,** the fee for independent auditor services by CliftonLarsonAllen LLP, Plymouth Meeting, PA was \$63,000 for Fiscal Year 2022-2023, and
- **WHEREAS,** the New Jersey Local Unit Pay to Play Law, N.J.S.A. 19:44A-20.4. et seq. provides that when the values of all contracts to a single vendor exceeds \$17,500 in the aggregate, that vendor is subject to the Pay-to-Play Law, and
- **WHEREAS**, the Vice President of Finance and Operations has determined that the total contract award will exceed \$17,500, and
- WHEREAS, CliftonLarsonAllen LLP, Plymouth Meeting, PA has completed and submitted Business Entity Disclosure and Political Contribution Disclosure Certifications, certifying that they have not made any reportable contributions to a political or candidate committee in the one year before their contract award, and they will be

prohibited from making any reportable contributions through the term of the contract, and

- **WHEREAS,** a Certification of Funds availability has been filed by the Vice President of Finance and Operations;
- NOW, THEREFORE BE IT RESOLVED that the Board of Trustees of UCNJ Union College of Union County, NJ award a contract to CliftonLarsonAllen LLP, Plymouth Meeting, PA to provide independent auditing services for Fiscal Year 2023-2024 and Fiscal Year 2024-2025 for a total contract award of \$144,000.

On motion duly made by Mr. Connolly, seconded by Mr. Castro and unanimously carried, the Board approved the Resolution for adoption.

EDUCATIONAL PLANNING AND POLICY COMMITTEE

Mrs. Zimmermann stated to the Board that at the Educational Planning and Policy meeting held earlier, Dr. Lown reported that at the Student Academic Symposia Union Honors hosted the Annual Honors Symposium where 30 student groups presented research poster presentations in the STEM and social science disciplines. She stated that stated that as of June 18, 2024, enrollment for Summer I is +1.3 in FTE hours and for Summer II is -2 in FTE hours. Enrollment for Fall is -17.1% in FTE hours.

- **WHEREAS,** changes in work-based skills and knowledge have resulted in the reevaluation of curriculum in relation to industry needs (Exhibit 1), and,
- **NOW, THEEFORE, BE IT RESOLVED** that the Liberal Studies, A.S. at UCNJ Union College of Union County, New Jersey be submitted to the New Jersey Presidents' Council and Office of the Secretary of Higher Education for deregistration.

Resolution E024-025 Program Deregistration – Liberal Studies, CT.

- **WHEREAS,** there has been a continuing lack of enrollment in the through Liberal Studies, CT. program (Exhibit 1) and,
- **WHEREAS,** changes in work-based skills and knowledge have resulted in the reevaluation of curriculum in relation to industry needs (Exhibit 1) and,
- **NOW, THEEFORE, BE IT RESOLVED** that the Liberal Studies, CT. at UCNJ Union College of Union County, New Jersey be submitted to the New Jersey Presidents' Council and Office of the Secretary of Higher Education for deregistration.

On motion duly made by Mrs. Zimmermann, seconded by Mr. Castro and unanimously carried, the Board approved the Resolution for adoption.

SAFETY REPORT

Dr. McMenamin stated that in compliance with the Cunningham – Ruiz Law (S485, codified at N.J.S.A. 18a:3B-71) requiring reporting of campus crimes and fire incidents for the period of April 12, 2024 through May 29, 2024, Public Safety advised that there was a theft of a bicycle from the rear of the Lessner Building. The incident was reported to the Elizabeth Police Department. There are no other issues to report.

BUDGET AND FINANCE COMMITTEE

Mr. Connolly stated that the Budget and Finance Committee met earlier and reviewed the Investment Report and reported that all investments are found to be in order and are within acceptable norms. A recent bid solicitation provided the College with various options, including a 6-month CD offering 5.5% interest rate, and additional \$3.0 million investments with ConnectOne and Northfield. This decision aligns with the College's short-term strategy to leverage the attractive rates offered by existing banking institutions.

Financial Report:

Mr. Connolly reviewed the Financial Report and stated variances within the report are due to the following:

- Increase in enrollment impacted the student receivable balance, tuition revenue and the variable compensation for instruction.
- The net increase in expenses is primarily due to increases in full-time and variable compensation as well as an increase in health benefits.

Current Estimate Report:

Mr. Connolly stated that also reviewed was the Current Estimate Report and reported that at this time, a transfer to Unrestricted Net Position of \$7.0 million is anticipated for fiscal year ended June 30, 2024.

Mr. Connolly stated that at the Budget and Finance Committee meeting held earlier, Dr. Wilkin presented the 2025-2029 Budget Forecast Review.

Resolution F024-046 - Authorization to Obligate County of Union Workforce Innovation and Opportunity Act Funding

WHEREAS, UCNJ Union College of Union County, NJ, as a comprehensive community college, seeks to provide career occupational training programs designed to assist adult and dislocated worker employment and training activities for eligible residents of the County of Union (the County) and support the development of a strong globally competitive labor force, targeting the key growth sectors within New Jersey, and

WHEREAS, the College applied to the County of Union for Workforce Innovation and Opportunity Act (WIOA) funding to coordinate the Workforce Innovation

Business Center (WIBC) which has been operating as an American Job Center Affiliate (AJCA) Career Service Center providing job search, training, and job development services to eligible residents of the County to meet the needs of business by supporting local businesses and organizations in their recruitment of employees according to grant requirements, and

- WHEREAS, local employers are able to leverage the resources of the College's academic and workforce initiatives which are carried out though the College's Center for Economic and Workforce Development (CEWD), the Industry Business Institute (IBI), and the Department of Continuing Education, and
- WHEREAS, the College has submitted its Fiscal Year 2025 proposal of \$500,000, based on the Request for Proposal (RFP), for Workforce Innovation and Opportunity Act (WIOA) funding to the County of Union to coordinate the Workforce Innovation Business Center (WIBC) to operate as an American Job Center Affiliate (AJCA) Career Service Center, and
- WHEREAS, the notification from the County of Union under the Workforce Innovation and Opportunity Act (WIOA) of a notice of award is expected to be received this summer with the contract arriving in early Fall 2024, and
- WHEREAS, the College has sufficient financial reserves to absorb any portion of Workforce Innovation and Opportunity Act (WIOA) funding for the Workforce Innovation Business Center (WIBC) obligated expenditures that are encumbered prior to the notification being received;
- NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of UCNJ Union College of Union County, NJ hereby authorizes the College to obligate Workforce Innovation and Opportunity Act (WIOA) funding from the County of Union in advance of the Board accepting the funds for the College so as to fully utilize the funding during Fiscal Year 2025 to the fullest extent possible.
- Resolution F024-047 Authorization to Obligate ABLE PLUS Consortium Grant Funding WHEREAS, UCNJ Union College of Union County, NJ as a comprehensive community college, seeks to provide career occupational training programs designed to assist College students and other Union County residents to become employed, and
- WHEREAS, the College applied, as the lead agency of the WIOA Title II, ABLE PLUS Consortium, to the State of New Jersey Department of Labor and Workforce Development (the "Department") for funding under the Workforce Investment Act of 1998, Title II, the Adult Education and Family Literacy Act for a four-year annual renewable contract for Fiscal Years 2022 through 2025, and
- **WHEREAS,** the College received notification for Fiscal Year 2025, year four of the continuation period, for ABLE PLUS Consortium Grant Funding in the amount of

- \$1,879,927 from the State of New Jersey Department of Labor and Workforce Development, and
- WHEREAS, the College will file its Fiscal Year 2025 budget application for ABLE PLUS Consortium Grant Funding with the State of New Jersey Department of Labor and Workforce Development for use of its allocation of \$1,879,927 referenced in the notification, and
- WHEREAS, notification from the State of New Jersey Department of Labor and Workforce Development informing the College that the application and proposed budget have been approved typically is received by the College two to three months after it receives the initial Notice of Award (NOA), and
- WHEREAS, the resulting approximate two-to-three month period to receive, procure and utilize the ABLE PLUS Consortium Grant Funding for the College and its Consortium partners would be subject to personnel displacement and long lead times inherent in the mandatory procurement and authorization efforts in compliance with the County College Contracts Law and related laws which could result in the inability to fully utilize the entirety of the ABLE PLUS Consortium Grant funding, and
- WHEREAS, the College has sufficient financial reserves to absorb any portion of ABLE PLUS Consortium Grant Funding obligated expenditures that are not ultimately approved by the State of New Jersey Department of Labor and Workforce Development;
- NOW, THERFORE, BE IT RESOLVED that the Board of Trustees of UCNJ Union College of Union County, NJ hereby authorizes the College to obligate the ABLE PLUS Consortium Grant Funding in advance of the Board accepting the funds for the College and its Consortium partners so as to fully utilize the funding during Fiscal Year 2025 to the fullest extent possible.

<u>Resolution F024-048 - Authorization to Obligate Carl D. Perkins Grant FY 2024-2025</u> <u>Funds</u>

- WHEREAS, UCNJ Union College of Union County, NJ as a comprehensive community college, seeks to provide career occupational training programs to prepare UCNJ Union College of Union County, NJ students and other Union County residents for employment, and
- WHEREAS, the Carl D. Perkins Strengthening Career and Technical Education for the 21st Century Grant ("Perkins Grant") is a federally authorized grant whose aim is to increase the academic achievement of career and technical education students and strengthen the connections of secondary and post-secondary education, and
- **WHEREAS,** on May 23, 2024, the State of New Jersey Department of Education ("NJDOE") notified the College of its preliminary allocation of \$912,461 under the Perkins Grant for FY2025, and

- WHEREAS, the College will file its Fiscal Year 2025 application and spending plan based on the allocation with the NJDOE for use of its Perkins allocation in the amount of \$912,461, principally covering instructional equipment, related materials and supplies, software and licenses, testing materials, and other costs, and
- **WHEREAS,** notification from the NJDOE that the College's application and spending plan are in "substantially approvable form" typically is received by the College several months into the grant year, and
- WHEREAS, the NJDOE will require that equipment expenditure items contained within the Fiscal Year 2025 spending plan be received, installed, and available for student instruction by April 30, 2025, and the resulting period to procure, receive and utilize the Perkins funded expenditures is subject to the long lead times inherent in the mandatory procurement and authorization efforts that are in compliance with the County College Contracts Law and related laws and regulations resulting in the possibility to fully utilize the entirety of the Perkins allocation, and
- **WHEREAS,** the College has sufficient financial reserves to absorb any portion of Perkins obligated expenditures that are not ultimately found to be in "substantially approvable form" by the NJDOE;
- NOW, THERFORE, BE IT RESOLVED that the Board of Trustees of UCNJ Union College of Union County, NJ hereby authorizes the College to obligate Carl D. Perkins Strengthening Career and Technical Education for the 21st Century Grant ("Perkins Grant") in advance of the Board accepting the funds so as to fully utilize Perkins Program funding during Fiscal Year 2025 to the fullest extent possible.

Resolution F024-049 - Displaced Homemaker Program Renewal

- **WHEREAS,** UCNJ Union College of Union County, NJ as a comprehensive community college, seeks to provide career occupational training programs designed to assist displaced homemakers and domestic violence victims in Union County, and
- **WHEREAS,** on May 10, 2024, the College received notification from the State of New Jersey Department of Children and Families that the Displaced Homemaker Program has been renewed for Fiscal Year 2025, and
- WHEREAS, the College will continue to provide job counseling and other supportive services, which includes domestic violence, for women of Union County through the Displaced Homemaker Program which provides expanded services with a priority to educational training to displaced homemakers who have been dependent on the income of another household member, which has been lost due to such hardships as death or disablement of a spouse, separation, or divorce, and

- **WHEREAS,** the College is expected to service 90 clients during the duration of this program by assisting qualified individuals to successfully complete a short term program that will lead to future employment, and
- **WHEREAS,** the College will provide the required documentation to the State of New Jersey, Department of Children and Families required by the Displaced Homemaker Program;
- NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of UCNJ Union College of Union County NJ will accept \$181,898 allocated to displaced homemakers for \$169,999 and \$11,899 for domestic violence victims from the State of New Jersey Department of Children and Families for the renewal of the Displaced Homemaker Program for the Fiscal Year 2025.

Resolution F024-050 - Authorization to Obligate Community College Opportunity Grant Funding

- **WHEREAS,** UCNJ Union College of Union County, NJ is a comprehensive community college providing quality, affordable, accessible educational programs that serve the greater Union County region, and
- WHEREAS, the Community College Opportunity Grant (CCOG) is the State of New Jersey's community college initiative that started as a pilot program in Fiscal Year 2019 to provide last dollar awards to New Jersey resident, community college students, for the opportunity to obtain a college education, and on February 26, 2021, the Governor signed Bill A4410 which permanently established this grant program which runs from July 1st of each year through June 30th, and
- WHEREAS, the grant is awarded through the State of New Jersey, Office of the Secretary of Higher Education (OSHE) and the purpose of the partnership with the College is to increase matriculation and support the goals of the Community College Opportunity Grant (CCOG) by implementing goals and strategies for capacity building and increasing enrollment, improving student completion, and reducing financial burdens on students, and
- WHEREAS, the College's funding amount for last Fiscal Year was \$414,569 and notification of this year's allocation and contract from the State of New Jersey Office of the Secretary of Higher Education (OSHE) is expected to be received this summer, and
- **WHEREAS**, the College has sufficient financial reserves to absorb any portion of the Community College Opportunity grant funding obligated expenditures that are encumbered prior to the contract being received;
- **NOW, THEREFORE, BE IT RESOLVED** that the Board of Trustees of UCNJ Union College of Union County, NJ hereby authorizes the College to obligate the Community College Opportunity Grant Funding in advance of the Board accepting the funds

so as to fully utilize the funding during Fiscal Year 2025 to the fullest extent possible.

Resolution F024-051 - Authority for the President to Execute Grant Funding Applications

- **WHEREAS,** UCNJ Union College of Union County, NJ is committed to the aggressive pursuit of grant funding from public and private sources to enhance College-wide programs and services, and
- **WHEREAS**, authorization to apply is routinely required of an applicant's governing body in advance of the submission of competitive applications for grant funding, and
- **WHEREAS,** such authorization is limited to the submission of these applications and does not bind the College in any manner, and
- **WHEREAS,** on the occasions when such applications are successful, the applicant's governing board must take action to formally accept or reject the grant funds pursuant to the application;
- **NOW, THEREFORE, BE IT RESOLVED** that the Board of Trustees of UCNJ Union College of Union County, NJ hereby grants the President authorization to submit competitive grant applications in amounts up to and including \$5,000,000 per application, during the Fiscal Year 2024-2025.

On motion duly made by Mr. Connolly, seconded by Mrs. Zimmermann and unanimously carried, the Board approved Resolutions F024-046 through F024-051 for adoption.

Resolution F024-052 - Content Management Software and Maintenance

- **WHEREAS,** support of technology applications including software licensing and maintenance are necessary components of the technological environment, which is essential to the teaching and administrative functions, in support of the mission of the College, and

- NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of UCNJ Union College of Union County, NJ grant authority to enter into an extension of the lease with Trinitas at the Kellogg Building for an additional ten (10) years, with the option for two (2) successive five-year (5) renewal terms, at an annual gross rental of \$286,000.

Resolution B024-012 - Additional Perimeter Fencing on Cranford Campus
