Lightning Strikes Twice: Union's Alumni Win Two Straight Cooke Scholarships

They're the community-college version of Oxford University's Rhodes Scholars. For a communitycollege graduate to earn a Jack Kent Cooke Foundation Scholarship, you have to graduate academically at the top of your class. You also have to be a wellrounded person who makes significant contributions to your college through some "give back to your community" form of extracurricular activities.

The Jack Kent Cooke Foundation Scholarship awards the largest scholarships in the community-college world: \$40,000 a year for two years to pay tuition for community college graduates transferring to a four-year institution to complete their bachelor's degree. Each year, more than 2,300 graduates from 1,200 community colleges apply. Only 75 are chosen.

Last year, for the first time since the creation of the Scholarship in 2000, a Union County College graduate won a Cooke scholarship. Nuno Pereira of Hillside graduated from Union with a Criminal Justice Degree and earned national recognition as a Cooke Scholar. The \$40,000-a-year award is helping defray his costs of a bachelor's degree at John Jay College of Criminal Justice.

A year later, lightning has struck a second time. McDaniel Jeantus got word that he is your alma mater's second

straight Cooke scholar. McDaniel's destination is Columbia University.

Both Nuno and McDaniel credit Union County College for helping make their dreams come true. Both were former presidents of the Student Government Association, both participated in the College's American Honors Program, and both led a number of communityoutreach initiatives.

Nuno earned a grade point average that has consistently placed him on our Honor Role. Along with leading the SGA, Nuno was a member of the Psi Beta Honor Society for Psychology students, a peer tutor, and a tutor in the Academic Learning Center. In fact, students considered Nuno to be one of the best tutors in the College and have cited him multiple times for his service.

McDaniel also had a stellar grade point average, and was a member of the Phi Theta Kappa Honor Society, Psi Beta Honor Society, and Mu Alpha Theta Honor Society. As SGA president, he

spearheaded a number of community initiatives, such as "Welcome Week" festivities for new students. McDaniel testified brilliantly on behalf of the College before the New Jersey Commission on College Affordability in the Fall. In the Spring, he served with distinction as a keynote speaker for a Black History Month event in February and again in July for a "Close the Gap" fundraiser to support African-American male students.

The JKC Foundation is a legacy of the billionaire owner of the Washington Redskins, Los Angeles Lakers, Los Angeles Kings, and the Los Angeles Wolves. A review panel of distinguished university faculty and admissions professionals judged the applicants based on a number of criteria, including academics, financial need, persistence, demonstrated leadership, and the desire to help others. care community hospital. Linda is the past President of the New Jersey Mental Health Counselors Association (A Division of NICA) and has served as a member on the Executive Board over the past six years.
