

#### LICENSURE REQUIREMENTS FOR ENROLLMENT

Applicants to the Paramedic Emergency Health Sciences Degree Program need to be aware of the New Jersey Administrative Code N.J.A.C. 8:41A, which lists the following requirements for enrollment in a Paramedic Education Program:

1. Attainment of the age of 18 by the first day of the program;
2. Possession of a high school diploma or its equivalent;
3. Possession of an Emergency Medical Technical license and BCLS for the Professional Rescuer certification. The student shall maintain Emergency Medical Technical license and BCLS for the Professional Rescuer certification throughout the duration of the Mobile Intensive Care Paramedic education program and until such time as he or she is either licensed as a Mobile Intensive Care Paramedic or terminated from the Mobile Intensive Care Paramedic education program. The student's Emergency Medical Technical license and BCLS for the Professional Rescuer certification shall be made available to Department staff upon demand;
4. Physical capability to perform all required skills and tasks of a Mobile Intensive Care Paramedic student as cited in the clinical and didactic portions of the program curriculum

The program application contains the following questions:

*Have you ever been charged, convicted, placed on probation, entered into a pre-trial intervention (PTI) program or entered into a plea bargain in connection with a violation of law under any state, the federal government, or any other jurisdiction, other than a minor traffic violation?*

*Have you ever been subjected to limitation, suspension, or termination of your right to practice in a health care occupation or voluntarily surrender a health care licensure in any state or to an agency authorizing the legal right to work?*

If you answered "yes" to the above questions, you will need to provide official documentation that fully describes the offense, current status and disposition of the case before the student is eligible for licensure.

**PROGRAM INFORMATION**

Paramedicine is a challenging profession in which professionals must be able to think critically, act quickly, understand and perform within their scope of practice and under medical direction, and earn the trust of patients and their families. Although paramedicine is a specialized field with specific training requirements, the situations encountered on a daily basis vary vastly from motor vehicle collisions to managing the care of cardiac arrest patients. Whatever the situation the paramedic is responsible for leading a team of pre-hospital providers, managing the care of the patient, and remaining calm and professional.

The program staff appreciate that students have unique learning styles and learn at their own pace. The instructors within the program use varied techniques that engage kinesthetic, visual, and auditory learners. Teamwork is paramount within the profession, and within the learning environment. Students are introduced to each skill and will be given the opportunity to practice the skill with an instructor. Once they have established minimum proficiency, students then evaluate one another to improve the skill, until a benchmark point when the skill is re-evaluated by an instructor. Students are expected to encourage and support one another while upholding progress standards.

Upon completion of the program, graduates will perform their job responsibilities independently and therefore are expected to assume responsibility for their own learning early in the program. Students are assigned independent work which is expected to be completed prior to each class session. Class sessions will then reinforce the concepts overviewed during the independent work, but students must complete the independent work in order to achieve success within the program. Program staff are available throughout the program to address student questions and concerns. It is the student's responsibility to make the program staff aware of questions and concerns. Students will graduate with entry-level proficiency as a Paramedic.

#### **MISSION STATEMENT**

The Union County College Emergency Health Science Paramedic Program is committed to preparing highly qualified entry level paramedics to serve the community in which they live. In addition to clinical knowledge, the program is focused on instilling professionalism, compassion, and a devotion of being a lifelong learner in every student.

#### **PROGRAM GOALS**

- Prepare competent entry-level Mobile Intensive Care Paramedics in the cognitive (knowledge), psychomotor (skills), and affective (behavior) domains.
- Graduate classes that achieve a 70% completion rate.
- Graduate classes that achieve a 70% first-attempt pass rate for National Registry Examinations, both cognitive and psychomotor.
- Graduate classes that are eligible for licensure as Mobile Intensive Care Paramedics
- Graduate classes that achieve a 70% positive job placement rate.
- Maintain approval from the New Jersey Office of Emergency Medical Services.
- Maintain accreditation from the Commission on Accreditation of Emergency Medical Services Programs.

#### **CODE OF ETHICS FOR MOBILE**

- Professional status as an Emergency Medical Services (EMS) provider is maintained and enriched by the willingness of the individual to accept and fulfill obligations to society, other medical professionals, and the EMS profession. As an EMS professional, I solemnly pledge myself to the following code of professional ethics:
- To conserve life, alleviate suffering, promote health, do no harm, and encourage the quality and equal availability of mobile healthcare.
- To provide services based on human need, with compassion and respect for human dignity, unrestricted by consideration of nationality, race, creed, color, or status; to not judge the merits of the patient's request for service, nor allow the patient's socioeconomic status to influence our demeanor or the care that we provide.
- To not use professional knowledge and skills in any enterprise detrimental to the public wellbeing.
- To respect and hold in confidence all information of a confidential nature obtained in the course of professional service unless required by law to divulge such information.
- To use social media in a responsible and professional manner that does not discredit, dishonor, or embarrass a mobile healthcare organization, co-workers, other health care practitioners, patients, individuals or the community at large.
- To maintain professional competence, striving always for clinical excellence in the delivery of patient care.
- To assume responsibility in upholding standards of professional practice and education.
- To assume responsibility for individual professional actions and judgment, both in dependent and independent emergency functions, and to know and uphold the laws which affect the mobile healthcare practice.
- To be aware of and participate in matters of legislation and regulation affecting mobile healthcare.
- To work cooperatively with associates and other healthcare professionals in the best interest of our patients.
- To refuse participation in unethical procedures and assume the responsibility to expose incompetence or unethical conduct of others to the appropriate authority in a proper and professional manner.

#### CURRICULUM

Prior to enrollment in the Paramedic Program, students must be a licensed New Jersey Emergency Medical Technician, and have completed all developmental course work in English and math. Students are encouraged to complete the general education requirements prior to enrollment, as the Paramedic Program is a rigorous and time-intensive curriculum. Anatomy and Physiology I, is a mandatory pre-requisite of Paramedic I. Anatomy and Physiology II is a mandatory co-requisite of Paramedic I.

**COURSE DESCRIPTIONS**

**PMD 110 – Paramedic I**

This course will focus on an introduction to NJ EMS operational model. Students will gain knowledge in the roles, responsibilities, and regulations which govern the profession. There will be a review of human structure and function that will relate to specific assessment skills and understanding of treatment modalities. Information will be presented on pharmacology, drug dosage calculation and administration, airway management and cardiology. The processes of assessment, diagnosis, formulation & implementation of treatment plans, and ongoing assessment of patients will be demonstrated and practiced. Students will demonstrate proficiency in the knowledge, skills, and abilities mandated by the National EMS Scope of Practice Model for conditions and components identified in the National EMS Core Content. Prerequisites: ENG 101, BIO 105, BIOL 105, MAT 113, and PSY 101. Co-requisite: BIO 106 and BIOL 106. 8 lecture and 9 laboratory hours per week. 11 credit hours.

**PMD 113 – Paramedic Clinical I**

This clinical course provides hands-on learning experiences for paramedic students in the hospital clinical setting. Specific clinical areas include interventions for advanced airway management, respiratory care, IV access, and cardiac care. Skills learned and demonstrated in the lab will be applied in the clinical area. Prerequisites: PMD 110, BIO 106, BIOL 106. Minimum 108 total clinical hours. 2 credit hours.

**PMD 114 – Paramedic Clinical II**

This course provides the educational clinical experience required to prepare the student to achieve licensure as a Paramedic. The clinical rotations are meant for application of learned theory and patient care skills, while under the direct observation and guidance of a preceptor. Clinical rotations will adhere to the N.J.A.C. 8:412A for required experiences. The majority of course hours will be completed at an acute care clinical site. Prerequisite: PMD 110, PMD 113. 135 clinical hours. 3 credit hours.

**PMD 213 – Paramedic II**

This course builds upon the information and clinical lab experiences of PMD 110. Further information is provided on assessments, interventions, and pharmaceutical agents that are used by paramedics for medical emergencies. Advanced EKG interpretation and age-specific content will be presented, along with trauma and disaster management. Lab experiences will reinforce classroom content and serve to demonstrate students' competency in specific assessment skills and management of emergency situations. Prerequisites: PMD 110, PMD 113, PMD 114. Co-requisite: PMD 214. 8 lecture and 9 laboratory hours per week. 11 credit hours.

**PMD 214 – Paramedic Clinical III**

This clinical course provides the educational clinical experience required to prepare the student to achieve National Registry certification and state licensure as a paramedic. Clinical rotations are meant for application of learned theory and patient care skills, while under the direct observation and guidance of a preceptor. Specific clinical areas are outlined by N.J.A.C. 8:41A Category II. Skills learned and demonstrated in the lab will be applied in the clinical area. Prerequisites: PMD 114, EMT licensure, BCLS, ACLS, and PALS certification must remain current while enrolled. 1 theory credit; minimum 180 total clinical hours. 5 credit hours.

**PMD 215 – Paramedic Field Internship**

This course provides the educational field internship experience required to prepare the student to achieve licensure as a paramedic. The field internship allows the paramedic student to apply learned theory and clinical skills while under the direct observation and guidance of a preceptor. The majority of the course hours will be completed at a New Jersey state licensed paramedic unit. Objectives of this course will adhere to N.J.A.C. 8:41A Category III/Field Experience. At the conclusion of this course, students will have a terminal competency assessment conducted by the Program Director and Medical Director. Information on pre-hospital life support for the paramedic, and review for the National Registry certification examination will be included. Prerequisite: PMD 213, PMD 214, 1 theory credit hour; 450 clinical hours; 11 credit hours.

**FITNESS FOR DUTY POLICY**

It is expected that students will come to class, college laboratory, and clinical laboratory in a condition fit for the competent and safe performance of their duties and that such a fit condition will be maintained throughout scheduled time. The objectives of this policy are to identify an impaired student and ensure safe, competent patient care.

Faculty are held accountable for ensuring that students are fit for duty and for taking prompt, appropriate, and decisive action whenever a student appears to be impaired.

Students who arrive in the clinical area, class, or other assignment and are considered by their instructor to be unfit for duty can expect to:

- a) Have their work performance and behavior witnessed and documented.
- b) Be questioned in private as to the nature of their problem.
- c) Be asked by their instructor to undergo a medical evaluation in the Emergency Room **or** have the observed behaviors witnessed by another health care professional.

**Procedure**

1. When substance abuse is suspected, the instructor will document observations, confront the student, and notify the Dean.

Observations may include but are not limited to:

- frequent absenteeism and/or tardiness (no documented medical reason for absence);
- drowsiness or sleepiness;
- smell of alcohol on the breath/body;
- increased inability to meet schedules and deadlines;
- slurred/incoherent speech or speech pattern different from normal speech;
- unusually aggressive behavior;
- unexplained change in mood;
- change in appearance;
- lack of manual dexterity;
- lack of or decreased coordination in body movement;
- inappropriate responses to stimuli;
- unexplained work-related accident or injury;
- inattentiveness to work.

2. If the student's observed behavior or performance raises any questions about the student's physical or emotional condition and /or fitness to perform the assignment safely, the instructor will:

- a) Interview the student regarding observations and ask for an explanation.
- b) Request the presence of a second instructor/health care professional to witness and confirm any observed performance and/or behavior problems; such observations may include but are not limited to above list.

- c) If deemed to be impaired the student will:

- ✓ meet with the Dean of Allied Sciences;
- ✓ be referred;
- ✓ **be assigned a grade of F;**
- ✓ **be dismissed from the program;**
- ✓ be ineligible for readmission.

**DISABILITY SUPPORT SERVICES**

**PROGRAM REQUIREMENTS**

1. Students must complete the entire paramedic training program within 36 months of beginning the program as per N.J.A.C. 8:41A.
2. The paramedic program consists of a prescribed set of Paramedic and general education courses. The paramedic courses are sequential and may be taken only by those students who have been accepted into the Paramedic Program.
3. Students must achieve a grade of 75 (C+) or better in Paramedic courses to continue in the program. Failure to maintain the minimum grade will result in dismissal from the program.
4. Students who have been dismissed from the program due to clinical failure are not eligible for readmission.
5. Students who are dismissed from the program will be considered for readmission under the current curriculum.
6. Students who have not enrolled in the program for one term or more must validate clinical skills as prescribed by the faculty before readmission.
7. Students must complete all required examinations administered during the program.
8. Students must adhere to the Fitness for Duty policy. Failure to adhere to this policy may result in the student receiving a grade of “F” and dismissal from the program.
9. Students must adhere to the Health Policy. Failure to meet the parameters of this policy may result in the student receiving a grade of “F” and dismissal from the program.
10. Students are responsible for all written and verbal information that are shared in scheduled classes.
11. Students must sit for tests on the scheduled dates. If a student misses a scheduled test for a valid reason, the student must provide supporting documentation and contact the course instructor to request a make-up. A date for the make up will be scheduled at the discretion of the instructor. A grade of “0” will be assigned if a student does not contact the instructor to reschedule a test or does not comply with the make-up date
12. Students are encouraged to seek assistance promptly from the instructor when and if they experience any degree of academic or clinical difficulty. If personal matters are interfering with academic or clinical efforts, the instructor should be kept informed.
13. Students who have disability alert forms should see their instructor about accommodations and must take their exams on the same day as the exam is scheduled.
14. Students may not be on clinical units outside of scheduled clinical hours.
15. All changes to clinical schedules must be approved by the student’s Clinical Educator/prior to the start of the scheduled clinical shift.
16. Students must comply with all College policies and Program policies at all times in all classes, laboratory sessions, and clinical sites.

#### **ORIENTATION FOR NEW STUDENTS**

Orientation is mandatory for students admitted to the Paramedic Program. New students must attend all mandatory orientations. Students must submit the following items prior to or during the orientation:

- Completed Physical Evaluation Form
  - Proof of Vaccination Titer and PPD – obtained by a physician or employer
    - Titer showing immunity or vaccination for Rubeola, Rubella, and Varicella, Hepatitis B Immunity vaccination or wavier form
    - Proof of PPD status – A negative two-step PPD skin test or Gold Blood Test for TB (if positive, a negative chest X-ray or pulmonary clearance within the past year; yearly requirement while enrolled)
    - Documentation of a single dose of the combined Tetanus, Diphtheria, and Pertussis vaccine
    - Documentation of a flu vaccination (yearly requirement)
    - OSHA Respirator Medical Evaluation Questionnaire reviewed by physician
  - Proof of 5-Panel Drug Test – Obtained by physician or employer
    - Cocaine, Marijuana, Opiates, Methamphetamines, Benzodiazepines
  - Proof of current Driver's Abstract
  - A note outlining any missing information and providing an expected date of compliance
- Note: Additional information may be required by hospital sponsors.*

#### **CLINICAL REQUIREMENTS**

##### **Physical Examination**

Each student admitted to the program is required to complete a physical examination. The physical examination requirement will affirm that each student is able to meet the demands of the program without compromising the patient or themselves. A Mantoux test must be done annually. The physical exam will remain valid for one year following the date it was conducted. A valid physical exam must be submitted prior to attendance at any clinical site.

##### **Criminal History Background Check**

Clinical agencies mandate criminal history background checks for all individuals engaged in patient care, and all students must undergo criminal history background checks. These checks are conducted by an external vendor, and these reports are sent to the college. If a student does not meet the established criteria for successful completion of the criminal history background check, that student will be dropped from the program. #### **Malpractice Insurance**

Students are required to carry their own malpractice insurance at a value of \$1,000,000.00 per claim and \$3,000,000.00 annual aggregate. To be admitted to clinical practice, proof of insurance coverage must be submitted to the Program Director prior to the start of any clinical sites. This policy can be obtained at: <http://hpsso.com>.

#### **NJ EMT Licensure & BCLS/ACLS/PALS Certification**

Students are required to maintain current EMT license, BCLS, ACLS, (once obtained during the program) and PALS (once obtained during the program) certification throughout the duration of the program. These certifications are required to be kept on the student's person during all clinical shifts. Current copies must be submitted to the Program Director. Any student with expired cards will not be permitted to attend any clinical sites until the updated documentation is provided to the Program Director.

#### **Identification**

Students are expected to have their Union County College Student ID available and visible at all times while on clinical sites. Students are also required to have a government-issued photo identification on their person at all times.

#### **Change of Name, Address, and Telephone Number**

The student is responsible for notifying the Program Director in writing of any changes in name, address or telephone number.

#### **Required Documentation**

1. A copy of current NJ EMT license, BCLS credential and driver's license (front and back)
2. Completed Physical Evaluation Form
  - a. Proof of Vaccination Titers and PPD - obtained by a physician or employer
  - b. Titers showing immunity or vaccination for Rubeola, Rubella and Varicella, Hepatitis B immunity, vaccination or waiver form.
  - c. Proof of PPD status - a negative two-step PPD skin test, or Gold blood test for TB (if positive, a negative chest x-ray or pulmonary clearance within the past year; yearly requirement while enrolled)
  - d. Documentation of a single dose of the combined Tetanus, Diphtheria and Pertussis vaccine
  - e. Documentation of flu vaccination (yearly requirement while enrolled)
  - f. OSHA Respirator Medical Evaluation Questionnaire reviewed by physician
3. Proof of 5 panel drug test - obtained by a physician or employer
  - a. Cocaine, Marijuana, Opiates, Methamphetamines, Benzodiazepines
4. Proof of criminal background check

6. A note outlining any missing information and providing an expected date of compliance

#### **Laboratory Requirements**

Laboratory time is incorporated into the didactic courses of the Paramedic Program. Any additional laboratory time needed beyond what is incorporated into the class schedule must be scheduled with an instructor prior to the date that the student is requesting to use the laboratory. Subject to availability of faculty and staff of the program, open lab sessions that may be used to acquire minimum skills competencies will be offered.

Laboratory time is utilized for the practice and testing of individual skills, as well as scenario-based education. All policies and rules in this section apply to both skills and scenarios. Conduct in the laboratory will be held to the same standard as conduct at the clinical site. Failure to comply with laboratory or clinical site policies for inappropriate conduct may result in removal from the laboratory.

#### **Laboratory Rules**

1. Students are expected to come to lab sessions prepared to perform the lab activities assigned for that day.
2. Students may not use the Paramedic laboratory or equipment without permission of an instructor.
3. Due to the necessity for scheduling adequate laboratory and class experiences, classes may be scheduled on evenings and/or Saturdays.
4. Students are required to sign a Laboratory Practical Participation Consent at the start of the program which will remain in effect for the duration of the program.
5. All accidents in the laboratory MUST be reported to the instructor.
6. If a student is injured during a laboratory session, the incident is immediately reported to the Program Director and the student must complete a College Incident Report.
7. Information on Standard Precautions is provided in the paramedic curriculum. All staff and students are required to follow Standard Precautions at all times and students will demonstrate understanding of this information in didactic courses and practical examinations. Gloves and masks are available in the lab for individual use and safety.
8. Material Safety Policy and Material Safety Data Sheets are maintained in the program office and the Paramedic laboratory cabinet for accessibility.
9. Uniforms must be worn at all times when in the laboratory and at the clinical sites.
10. Each student is expected to clean the work area after completing an assessment or practice session.
11. Students are responsible for maintaining and restocking scenario bags at the end of every scenario and at the conclusion of the lab session.

Practice of skills in the laboratory will include the use of mannequins and other simulators, along with instructional supplies appropriate to the skills.

#### **Academic Progress**

Student will follow the program as outlined in the course catalog of their incoming year. A student program plan is completed by each student with the Program Director at the time of admission to the program. Students must meet with the Program Director regarding any individual needs.

According to N.J.A.C. 8:41 A, the period of the student training experience may not exceed 36 months from the start of their didactic portion to the completion of Field Internship and clinical education should not exceed 18 months from the end of the completion of the didactic portion of training.

#### **Course Participation**

The Paramedic program faculty view attending class and completing online course activities as an integral part of the program and a critical step toward successful completion of each course.

1. It is expected that each student attends all classes and complete all assignments/activities, and report for class on time.
2. All students must attend the program orientation session prior to the start. of the program

#### **Attendance**

Paramedic program is a fast-paced and rigorous academic undertaking and missing one scheduled class could result in poor academic outcomes. This program is designed to meet state and national credit hour requirement and attendance at all classes, laboratories, and clinical opportunities is expected.

#### **Absence from Class or Clinical Opportunities**

A student who is unable to attend a scheduled class or clinical opportunity must contact either the Program Director or the Clinical Instructor before the start of class or clinical to report the absence. An **EXCUSED** absence may be granted for any of the following extenuating reasons: death in the family, illness, military duty, court appearance, or declared disasters. Following an absence, a student must provide a valid documentation that supports the emergency. It is the responsibility of the student to arrange a make-up with the instructor for an excused absence.

#### **Tardiness**

Classes will start on time as scheduled. Student who arrive late to class or clinical opportunity are considered tardy. Students are responsible for the material and course work that is covered in their absence. Students will have one (1) week from the time they return to make up any course work that was missed in their absence.

#### Academic Integrity

3. Please refer to the syllabus for each course for the specific grading procedures related to that course.
4. Remediation opportunities will be offered only at the discretion of the instructor and Program Director.
5. Students whose course grade or final exam performance does not reflect C+ (75%) fail the course and will be dismissed from the program.

#### **Advanced Placement**

1. There is an Advanced Placement option for those individuals who currently hold New Jersey Paramedic licensure, who wish to pursue completion of the AAS degree. This functions a bridge for individuals who have a paramedic license to complete course work to obtain a Associates of Applied Science in Paramedicine.
2. Those individuals may be awarded up to 38 credits for prior paramedic course work with current BCLS, ACLS, PALS, and PHTLS certifications.
3. Students are required to take one (1) additional course within the paramedic department.
4. Students must complete general education course work as listed in course catalog under which they enrolled.

#### **Post Examination/Quiz Reviews**

Faculty believe that exam and quiz reviews are learning opportunities for every student. Students are encouraged to participate in these reviews. This will allow for students to identify their individual strengths and weaknesses. Exam/quiz reviews will be conducted in a mutually respectful atmosphere for learning and will be confined to review of exam/quiz questions only.

#### **Rules for Examinations**

1. All exams are to be individual and closed book.
2. No communication between students during the examination is permitted.
3. Inform the instructor if there are questions or if additional information is needed.
4. The instructor will answer only technical question about exam and will not any questions related to exam content itself.
5. One piece of blank paper is permitted for calculation or notes. The piece of scrap paper must be returned to the instructor at the end of the exam.
6. Students will be required to sit at least one desk away from another student.
7. Students may not share information about an examination with other students.
8. Honesty is the responsibility of each student at all times.
9. If the student is late for an examination, no additional time will be given for the examination. If there is an emergency, please contact the instructor immediately. Provision will be made for students with disabilities according to College policy.
10. Cell phones are not allowed during examinations and should not be on their person. If a student is found using a cell phone during the exam, it will be assumed that the student is cheating and in violation of Academic Integrity Policy.
11. All suspicious activity will be investigated.
12. A student who is found cheating will be dismissed without any opportunity for readmission to the program.

#### High Stakes Exam Review Policy

The definition of a high stakes exam for the purpose of this policy includes, any exam that could result in dismissal from the program. After all exams have been taken, item analysis will be performed using CANVAS or EMS Testing test analytical software.

All the questions that meet the following criteria will be reviewed:

- P-Value of  $< 0.5$
- Discrimination of  $< 0$
- Point Biserial Score of  $< 0.2$

After reviewing the item one of the following actions should take place:

- Confirmed for accuracy and relevance to current and local practice – classroom review is undertaken
- Discarded for inaccuracy or lack of relevance to current and local practice – question is replaced
- Edited for improvements in language or changes in distractors if administered in Canvas

Following the item analysis by the Paramedic Program Director or Lead Instructor, the item analysis should be reviewed with any faculty that participated in the educational material that was to be covered by that exam and the program's Medical Director. The goal of this review is to ensure that all faculty agree with the item analysis and to identify areas of weakness where the program can improve the educational experience of the students.

#### Clinical Documentation

Students are responsible for maintaining a clinical binder and maintain all documentation on *Platinum Planner*, the online skill tracking service. Students will be responsible for ensuring all clinical documents and forms are filled out in their entirety and organized neatly in binder.

1. All clinical documentation must be completed and signed by the clinical instructor at the completion of each clinical shifts.
2. All clinical documentation must be uploaded in Platinum Planner within 48 hours of the completion of the clinical shift.

#### **Voluntary Withdrawal from Program**

A student who wishes to withdraw from the program may do so according to the policy set forth by Union County College. Students should consult with the Program Director before withdrawing. If a student withdraws after the withdrawal date of the college for a particular semester, a grade of “F” or “UF” will be awarded for all courses in which the student was enrolled during that semester.

#### **Appeals Process**

1. Students who wish to appeal issues that have not been resolved to their satisfaction may initiate the appeal process.
2. A student who is dismissed from the paramedic program because of unsafe clinical performance or failure to achieve clinical learning outcomes may appeal the decision if he or she believes that the faculty member has inconsistently applied department policy or the faculty member has rendered a decision without considering all of the pertinent facts. The evaluation of the merit of these facts is solely within the clinical judgement of the faculty member. Only the lack of consideration of facts is a reason for appeal.
3. The burden of proof is on the student, who must be prepared to substantiate his or her argument with information.
4. Students only have until the end of the next semester to appeal a grade/decision.

#### **Readmission**

Students who have been dismissed from the program due to classroom failure or voluntary withdrawal may re-apply to the program. Students must repeat all course work. Students may have to repeat all course work in the program based on their timeline in accordance with N.J.A.C. 8:41A: <http://www.nj.gov/health/ems/documents/reg-enforcement/njac841ar.pdf>.

#### **Health Policy**

A student who is injured in laboratory or at a clinical site must immediately report the incident to the instructor, who will complete a laboratory/clinical site incident report. If the injury occurs in a hospital, the student will be seen in the hospital emergency room at no expense to the hospital. The decision to send the student to the emergency room will be made by the instructor. Refusal by the student to go to the emergency room may result in the student being assigned a grade of “F” and being dismissed from the program.

College incident reports and records related to clinical incidents will be released to the hospital, if requested, for use by the hospital in any legal or regulatory proceeding which may involve the

college, the student, or the clinical site. If a student is injured in the college laboratory, an incident report must be submitted to the Dean of Allied Sciences.

The paramedic program will include clinical work performed in hospitals and field units and will include direct care or exposure to clients with a variety of illnesses and diseases, including the handling of and/or contact with human body fluids. Therefore, students should understand that they may or will be exposed to disease-carrying bacteria and microorganisms and come in contact with patient situations that could be hazardous to individuals who are pregnant.

Students who have a latex allergy must inform their instructor at the beginning of each semester and are responsible for providing appropriate gloves if necessary. Students who have special physical or allergic needs must provide medical documentation. After hospitalization, surgery, or childbirth, students must submit medical clearance to the Program Director.

#### **Uniform**

Students are expected to arrive for class, laboratory, and clinical site rotations\* (\*unless otherwise directed by your clinical educator) in the Union County College approved uniform, including required uniform shirt navy blue uniform pants, black safety shoes/boots with socks, a black belt, and UCC Student ID (clinical site ID is required at these locations as well).

Long hair must be pulled back so as not to interfere with patient care or create a contamination risk.

Fingernails must be trimmed to an appropriate length and conservative color polish (if any) must be worn. Artificial nails are not permitted under any circumstances per CDC recommendations regarding infections associated with this cosmetic product.

Equipment to be brought to each class, lab, and clinical site rotation includes:

- Watch with second hand
- Pen
- Stethoscope
- Trauma shears
- Pen light
- Pocket guides
- Notepads

Students shall present a clean and neat appearance to both patients and colleagues. Your appearance reflects you, the college, and the clinical site. Students whose appearance does not meet the above parameters will be excluded from participation in class, laboratory, and clinical site rotation, and must make up the missed time.

#### **Chaperoning Policy**

When students are performing procedures that are patient sensitive, the student should talk with the instructor to receive guidance and to determine if the presence of another individual is advisable. The instructor may, at any time and at his or her sole discretion, require that another individual be present during any patient interaction.

#### **Non-Discrimination Policy**

Union County College Emergency Health Science Paramedic Program strictly prohibits misconduct including harassment, sexual harassment, sexual violence and any other form of discrimination or misconduct. For more information related to this policy, please refer to the Union County College Student Handbook.

#### **Confidentiality Policy**

During the clinical and field internship, the student is required to maintain confidentiality of all patient information, as specified in the Student-Hospital contact and as outlined in the Patient Privacy/HIPAA policies and procedures. Students are held to the same standards as other healthcare worker when in their clinicals and field internship experiences. Students are to protect protected health information (HPI), which includes but not limited to, name, date of birth, social security number, ethnicity, identifying features, identifying medical history, etc.. Students are held to the standards set by the State of New Jersey and Health Insurance Portability and Accountability Act (HIPAA) of 1996. Breaches of confidentiality will result in disciplinary actions, which can include dismissal from the Paramedic Program without opportunity for readmission.

Students are not permitted to record lecture or laboratory material without expressed written consent from the instructors.

#### **Recording and Sharing Policy**

While participating in the skill practicum courses, students may be videotaped for education purposes. If a copy of the video is provided to the students for review, the video is prohibited from being shown to people outside of class.

Students are prohibited from sharing the videos or posting them to any public forum. Students are not permitted to record information from classes or clinical experiences in any format without the permission of the Instructors and Program Director. Written consents are required to take photos and video of fellow students, faculty members and patients. This policy is

extended to the use of cell phones and all other electronics equipment's that is capable of recording audio and visual information.

Violation of this policy will be considered a breach of confidentiality and students will be held to those disciplinary actions.

**Social Networking Policy**

Students may not share images of fellow students, instructors, administrators, or academic or clinical documentation on any Facebook, Twitter, YouTube, email, or other electronic format. Students who violate this policy will be subject to dismissal from the Paramedic Program

The program recognizes that students may engage in "social networking" while enrolled in courses. "Social networking," for purposes of this policy, includes all types of postings on the Internet, including, but not limited to, social networking sites, (such as Facebook®, MySpace®, or LinkedIn®); blogs and other on-line journals and diaries; bulletin boards and chat rooms; microblogging, such as Twitter®; and the posting of video on YouTube® and similar media. Social networking also includes permitting or not removing postings by others where a student can control the content of postings, such as on a personal profile or blog. This policy applies to social networking while participating as a student in the Paramedic Emergency Health Science Program at Union County College.

Students who engage in social networking should be mindful that their postings, even if done off premises, could have an adverse effect on the program's community of interest, students, and/or clinical sites. For example, the information posted could be confidential student or patient information. In addition, some readers may view students as a de facto spokesperson for the College and/or Program.

To reduce the likelihood that personal social networking will have any adverse effects so far as the College or program is concerned, students are expected to observe the following guidelines when social networking:

- Do not engage in social networking using any of the College's electronic resources during class, clinical, or internship experience. Social Networking by Paramedic students is subject to all of the policies listed in the Union County College Student Handbook and in the Paramedic Emergency Health Science Paramedic Program Student Handbook.
- Instructors/ Preceptors should not send "friend" requests to students, and students should refrain from sending "friend" requests to instructors/preceptors. Any student may reject a friend request from any other instructor/preceptor without repercussion.

- Avoid defaming or otherwise discrediting Union County College and/or the Paramedic Emergency Health Science Program, its instructors, staff, faculty, or services.
- Avoid using the College and/or the Paramedic Emergency Health Science Program logo, or photographs of the College's premises or products.
- Avoid disclosing personal or contact information, or post photographs, of other students, instructors, or faculty without their prior permission.

Students who violate this policy will be referred to the Student Code of Conduct Officer.

#### **Electronic Device Policy**

Cell phones, smart watches, and other personal electronic devices must be turned off during classroom hours and meeting time. They must be kept on silence mode at all times during didactic and clinical experiences. If student is found to be using an electronic device during class, the student will be asked to leave and will not receive credit for that class period.

If student is expecting an emergency phone call, the student must inform the instructor of their circumstances. Phone must be kept on silent mode during class. Student will be responsible for leaving the classroom or laboratory prior to answering phone call.

Text messaging, answering phone calls, or listening to voicemails are not permitted during class, lab, or clinical experience. Students may check electronic devices during breaks. Breaks are not considered time spent between rotations during class or laboratory sessions.

#### **Student Conduct**

Students are held to all policies and procedures listed in the Union County College Student Handbook.

#### **Certification Courses**

During the year, certification classes will be offered as part of this program. This cost is the responsibility of each student. College tuition does not cover the cost of these specific course completion cards. All students must attend and successfully complete the courses provided by the program, regardless of their status. In the event of student does not fulfill the requirements for course completion, the student must remediate. This process may require the student to attend an off-site course on his/her own time and expense.

American Heart Association Open Resource Testing Policy does not apply to students enrolled in the Paramedic Emergency Health Science Paramedic Program.

#### **Internet**

The Paramedic Program requires that students have internet access. This program utilizes three different online resources including CANVAS (UCC Learning Management System), Platinum Planner (Online Skill Tracking Software), and EMS Testing (Online Testing System). It is the responsibility of each student to ensure they have internet access for the duration of the program. Computer and internet access is available at all Union County College campuses for student use. Lack of internet access will not be considered an excuse for the inability to turn in an assignment late.

#### **Terminal Competency Examination**

Students are required to complete a terminal competency examination prior to challenging any National Registry Paramedic Exam. This is a summative program evaluation that is based on all material covered in the program. At a minimum, the examination will include a cognitive assessment and Out-of-hospital integrated psychomotor scenario.

In order to be eligible for Terminal Competency, the student must have:

- Satisfied all minimum clinical hour requirements
- Satisfied all minimum skill requirements.
- Completed all general education courses
- Received a C+ or better in all didactic courses

The student must demonstrate entry-level paramedic competency in order to pass the evaluation. If the student does not exhibit entry-level competency, remediation will be required. Please refer to UCC Paramedic Program Remediation Policy for more information.

#### **Office Hours**

The Paramedic Program Director has set office hours that will be posted. If students cannot meet during these times, the student may make an appointment that will be convenient for both parties.

#### **Academic Advising**

Due to the unique nature of the program, the Paramedic Program Director is the primary point of contact for academic advisement. Academic Advisors are available at each of the Union County College campuses for assistance with general education planning and questions. #### **Tutoring**



**RELEASE FORM**

The Union County College Paramedic Program consists of two components, didactic (classroom learning) and clinical/lab/simulation experiences. Upon completion of this program, a national examination is required for licensure.

In order to begin clinical experiences, it may be necessary for the student to have results submitted to a facility with regards to drug screening, HIV testing, criminal background, psychiatric illness and/or substance abuse, or academic concerns. Many of the affiliation sites require a copy of current information (no more than one year old). Students may be required to have two physical examinations completed by their own personal physician during the course of the program. Some facilities may require additional screening such as a more in-depth drug screening and/or a two or three step Mantoux test for tuberculosis.

Students are required to make copies of these physical examination forms and submit them to clinical sites upon request. A copy of the documents is kept in a file at Union County College and will be submitted to the clinical site upon request if a student has failed to do so or if the student is unable to do so for any reason.

**FITNESS FOR DUTY CONTRACT**

The Union County College Paramedic Program has a Fitness for Duty Policy (see page 12 of this handbook). This policy is concerned with performance problems related to impairment and documentation of the same. Students are required to adhere to this Policy; noncompliance with the Policy will result in a diagnostic evaluation including supervised blood alcohol levels, urine studies, referral for treatment, and may result in dismissal from the Paramedic Program.



**PRIVACY AND CONFIDENTIALITY AGREEMENT**

The Health Insurance Portability and Accountability Act (HIPAA) is a set of federal rules that defines what information is protected, sets limits on how that information may be used or shared, and provides patients with certain rights regarding their information.
